My lifelong personal and professional passion is to contribute my skills, talents, energy, and experience to organizations and issues that create value for our society. My experience reflects this commitment, as a high school teacher, State employee, and now a consultant to the public sector.

Public Sector Professional Experience

Commonwealth of Massachusetts, Office of the Comptroller, State Comptroller, 1989-1999. *Massachusetts is the* 12th largest state with annual expenditures over \$55B. The Office of the Comptroller (OSC) is an independent entity within the executive branch. Its mission is to provide leadership and guidance in matters pertaining to state finance. The Comptroller is appointed by the Governor and serves independently.

My duties as Comptroller included establishing accounting policy and procedures for all departments across all branches of government, operating the state accounting and payroll systems, managing the state single audit, producing the Comprehensive Annual Financial report (CAFR) and other authoritative financial reports, reviewing and approving certain transactions (for example all contracts), overseeing state agency internal control systems and compliance to regulations and laws, assisting the Governor and Legislature in proposing and reviewing changes to state finance law, and conducting special projects. With the support of an excellent staff, we accomplished several strategic goals.

• Enhanced accountability and transparency. I have been an active participant in the Governmental Accounting Standards Board (GASB) due process, organizing the Commonwealth's point of view and responding to discussion memoranda and exposure drafts. I was an active participant on the task force to develop the landmark accounting standard for measurement focus basis of accounting (subsequently GASB #34), including testifying at GASB Board meetings. In my first year as Comptroller I set the goal that the Commonwealth CAFR should earn the Government Finance Officer's Association (GFOA) Certificate of Achievement for Excellence in Financial Reporting. The Commonwealth continues to earn the GFOA Certificate to this day.

- Institutionalized practices and behaviors to promote prudent stewardship and accomplish a favorable financial condition. The Commonwealth still follows many of the policies I promoted. There are dozens of examples, many of which relate to my strategy to leverage GASB and Generally Accepted Accounting Principles (GAAP), with a few highlights as follows:
 - Persuaded Legislative and Executive leaders to align GAAP accounting and reporting, state finance law, and the annual budget process to reduce "budget balancing gimmicks."
 - Developed and persuaded the Legislature and Executive officials to enact statutory triggers based on principles of interperiod equity, which increased the "rainy day fund" from less than \$50M to over \$2B.
 - Promoted GAAP principles and reports to be understood, respected, and required by statute (whereas previously GAAP reporting was merely an administrative policy).
- Established the Office of the State Comptroller as the central and authoritative entity for fact-based, non-partisan, financial information. Prior to my administration, the Governor, Legislature, and various public interest groups each had their own definition of revenues, expenditures, and fiscal balance. I conducted an extensive education and advocacy campaign which directly resulted in changes to state finance law and consensus of all stakeholders on a "single source of truth". All parties now rely upon OSC information, meaning the debate around the budget has shifted from "debating the numbers" to "debating the policy." The quality and accuracy of the budget process has been vastly improved.
- Aggressively leveraged technology as both a change agent and enabler to improve financial management. In my administration I directed over 40 technology-based projects. A few examples include the following:
 - o Implemented a statewide non-tax revenue accounting and collection system (which increased collections by over \$900M in my 10-year term);
 - o Designed and implemented a comprehensive data warehouse;
 - Sponsored and directed projects to decrease paper checks, increase EFT, and transition all welfare and food assistance to Electronic Benefits Transfer (EBT);
 - Automated the provisions of the 1990 Federal Cash Management Improvement Act (CMIA);
 - Completed several eCommerce projects, including the first in the nation website for electronic purchasing and a self-service website for vendors and employees to obtain remittance information on payments.
- <u>Professionalized the workforce.</u> For certain positions I encouraged and assisted
 people to earn professional credentials such as CPA and CGFM. To provide a feeder
 system of new talent, I developed a very successful student intern program with local
 universities. I created ongoing educational and training programs to develop and
 increase knowledge in public accounting. Key elements of this strategy included

continuing professional education, a career ladder, and succession planning. A good example is my Deputy who succeeded me and served as Comptroller for many years.

• Promoted cross boundary coordination and cooperation. I have been one of the strongest proponents of the proposition that our government institutions have significant interdependencies and thus major opportunities for improvement can be accomplished through enhanced coordination. At the national level I spearheaded the interaction between the federal CFO council and the National Association of State Comptrollers (NASC), on issues like CMIA, OMB A-87, and the Single Audit Act. I testified before the U.S. Congress several times on legislation to improve the federal-state financial relationship. I led state representation on the federal EBT task force and subsequently the National Automated Clearing House Association (NACHA) EBT Council, resulting in rapid, nationwide deployment of EBT. At the Commonwealth level I promoted an unprecedented degree of interagency cooperation. I created the environment and systems whereby the University of Massachusetts and several independent public authorities produced audited financial reports with unqualified audit opinions earning the GFOA Certificate of Excellence.
