* NOTES on Water Management Permit Expiration and Renewal Dates

Pursuant to M.G.L. c. 30A, section 13, and 310 CMR 36.18(7), if a permit renewal application is filed by the filing deadline, the existing permit will be administratively continued in force and effect until MassDEP issues a final decision on the renewal application.

Since 2010, for permits that were not in administrative continuance, expiration dates have been extended:

- by 4 years by Chapter 240 of the Acts of 2010, as amended by Chapter 238 of the Acts of 2012, collectively known as the Permit Extension Act.
- by 462 days by the Governor's COVID-19 Order No. 42, "Order Resuming State Permitting Deadlines and Continuing to Extend the Validity of Certain State Permits," July 2, 2020.
