DECISION

CANAL PARK SERVERS LLC DBA HOLIDAY INN SELECT 15 MIDDLESEX CANAL PARK S.W. QUADRANT HWYS WOBURN, MA 01801 LICENSE#: 149800016 HEARD 3/27/2012

Canal Park Servers LLC dba Holiday Inn Select (the "Licensee") holds an all alcoholic beverages license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 27, 2012, regarding an alleged violation of c.138, §34 (2 counts). Prior to the commencement of the hearing, the licensee stipulated to the violations alleged in Investigator Paul Capurso's Investigative Report.

FACTS

- 1. On Friday, December 9, 2011, at approximately 10:30 p. m., Investigators Caroline Guarino and Paul Capurso investigated the business operation of Canal Park Servers LLC dba Holiday Inn Select to determine the manner in which their business was conducted.
- 2. Investigators observed several youthful looking patrons in possession of alcoholic beverages.
- 3. Investigators identified themselves and asked for identification.
- 4. Two youthful looking patrons, part of a large office party, stated they were under the age of twenty-one, and each provided a Massachusetts Driver's License for identification.
- 5. Both underage patrons stated that they were not asked for ID.
- 6. Investigators informed the manager on duty, Mr. Nathan Amaral, of the violation and identified the underage patrons to him.
- 7. Investigators informed Mr. Amaral that a report would be submitted to the Chief Investigator for review.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated c.138, §34 (2 counts). Therefore, the Commission suspends the license for four (4) days of which four (4) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
