#### DECISION

AMZ Convenience Inc. d/b/a Colony Farms ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, May 28, 2024, regarding an alleged violation of M.G.L. Ch. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (2 Counts). Prior to the commencement of the hearing the Licensee stipulated to facts alleged in Special Investigator Gould's report.

# There is one (1) audio recording of this hearing.

- 1. On Thursday, April 18, 2024, at approximately 7:40 p.m., Special Investigators Velez and Gould ("Investigators") inspected AMZ Convenience Inc. d/b/a Colony Farms to determine the way business was being conducted.
- 2. At approximately 7:50 p.m., Investigators observed two youthful appearing male individuals enter the licensed premises and exit minutes later in possession of alcoholic beverages.
- 3. Investigators approached the males, identified themselves and asked to see proof of legal age to purchase and/or possess alcoholic beverages.

- 4. Underage #1, actual date of birth 7/11/2003 (age 20), was in possession of one 18-pack of Rolling Rock beer, one 30-pack of Natural Ice beer, and two Buzzballs. He provided to Investigators a fraudulent Connecticut driver's license bearing his name but a different birth date. Underage #1 then provided Investigators with his true New York driver's license.
- 5. Underage #2, actual date of birth 3/28/2004 (age 20), was in possession of two Buzzballs. He provided Investigators with a fraudulent Colorado driver's license bearing his name but a different birth date.
- 6. At approximately 8:15 p.m., Investigators entered the licensed premises and spoke to a male employee, informed him of the violations, and that a report would be submitted to the Chief Investigator for further action.
- 7. Abebaw Tessema, Licensee, appeared at the Commission hearing. The Commission was informed of steps taken to prevent future sales to persons under the age of twenty-one. The Licensee has purchased an updated identification scanner (Exhibit A) and has instituted a new policy wherein any patrons under the age of twenty-five must produce a 2<sup>nd</sup> form of identification which must include their name and address.
- 8. The Licensee has held a license under M.G.L. c. 138, § 15 since 2018 with no prior violations.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. Ch. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (2 Counts). Therefore, the Commission suspends the license for a period of two days which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.
