Guru Ne Sang Corp. d/b/a Austin Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 8, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Bolcome's Report.

The following documents are in evidence:

- 1. Investigator Bolcome's Compliance Check Field Report;
- 2. Licensee Stipulation of Fact;
- 3. Copy of License Application Approval 5/10/2018.

There is one (1) audio recording of this hearing.

FACTS

- 1. On Saturday, July 20, 2019, at approximately 2:57 p.m., Investigators Di Cicco and Bolcome ("Investigators") investigated the business of Guru Ne Sang Corp. d/b/a Austin Liquors.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 16-ounce can of Bud Light beer for three dollars and four cents (\$3.04). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2018 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
