After a hearing on September 11, 2012, the Commission finds International Lounge LLC dba International Lounge in violation of 204 CMR 2.05 (2), to wit: M.G.L. c.138 §34- Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (2 Counts).

The Commission suspends the licensee's license for a total of two (2) days to be served. The suspension shall commence on Wednesday, October 31, 2012 and terminate on Thursday, November 1, 2012. The license will be delivered to the Local Licensing Board or its designee on Wednesday, October 31, 2012 at 9:00 A.M. It will be returned to the licensee Friday, November 2, 2012.

You are advised that pursuant to the provisions of M.G.L. c.138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form. All checks must be certified and accompanied by the enclosed form, which must be signed by a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

DECISION

INTERNATIONAL LOUNGE LLC DBA INTERNATIONAL LOUNGE 27 PLEASANT STREET WORCESTER, MA 01608 LICENSE#: 150800548 HEARD: 09/11/2012

International Lounge LLC dba International Lounge (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 11, 2012, regarding an alleged violation of 204 CMR 2.05 (2), to wit: M.G.L. c.138 §34- Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (2 Counts).

According to Investigator Kujawski's Report.

Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Kujawski's Report.

The following documents and physical items are in evidence:

- 1. Licensee's Stipulation of Facts;
- 2. Investigator Kujawski's Investigative Report dated May 18, 2012;
- 3. RMV Printout of Driver's License for Ms. Kasey Dube; and
- 4. Photocopies of Massachusetts Driver's License (E. Gauvin) and New York State Driver's License (E. Baker).

There is one (1) audio recording of this hearing.

FACTS

- 1. On Friday, May 18, 2012, at approximately 1:35 p.m., Investigators Keefe, Bailey, and Kujawski conducted an investigation of International Lounge LLC dba International Lounge to determine the manner in which their business was being conducted.
- 2. Investigators observed two (2) youthful looking individuals in possession of alcoholic beverages.
- 3. Investigators identified themselves to the individuals and asked to see their identification.
- 4. One underage female, Ms. Kasey Dube, was in possession of a Coors Light Beer. She provided her date of birth as August 3, 1992, age nineteen (19) years.
- 5. The underage stated that she had used a New York Driver's License in the name of E. Baker, with a date of birth of March 20, 1987, age twenty-five (25) years, to enter the licensed premises.

- 6. The other underage female, Ms. Jessica Megurn, was in possession of a Coors Light beer. She provided her date of birth as June 7, 1991, age twenty (20) years.
- 7. Ms. Megurn used a Massachusetts Driver's License in the name of E. Gauvin with a date of birth of June 15, 1989, age twenty-three (23) years, to enter the licensed premises.
- 8. Based on the investigators training and experience, the photo on the Massachusetts Driver's License did not resemble the underage individual, Ms. Megurn.
- 9. Investigators spoke with the bartender on duty, Ms. Orela Gjusta, and advised her of the violation.
- 10. Investigators informed Ms. Gjusta that a report would be submitted to the Chief Investigator for further action.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated of 204 CMR 2.05 (2), to wit: M.G.L. c.138 §34- Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (2 Counts). Therefore, the Commission suspends the license for seven (7) days of which two (2) days will be served and five (5) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
