J. E. Mullaly's Package Store Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 8, 2019, regarding an alleged violation of 204 CMR 2.05 (2)-Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Di Cicco's Report.

- 2. Licensee Stipulation of Fact;
- 3. ABCC Decision 11/25/2002;

FACTS

- 1. On Saturday, July 20, 2019, at approximately 3:20 p.m., Investigators Bolcome and Di Cicco ("Investigators") investigated the business of J. E. Mullaly's Package Store Inc.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 25-ounce can of Bud Light beer for two dollars and fifty cents (\$2.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1960 with one prior violation.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
