**K LIQUOR CORP. D/B/A MASS LIQUOR

K Liqueur Corp. d/b/a Mass Liqueur ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, August 12, 2025, regarding an alleged violation of M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under 21 years of age (1 Count). Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigator Binienda's Report.

The following documents are in evidence:

1. Report of Investigator J. Binienda;
2. ABCC Licensing Authority Certification, Transfer of License Approved, 12/28/2023;
3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

1. On Friday, September 6, 2024, at approximately 9:45 p.m., Investigators Gould, Kenny, and Deputy Chief Investigator Binienda ("Investigators") inspected the business operation of K Liqueur Corp. d/b/a Mass Liqueur ("Licensee").
2. Investigators parked outside the licensed premises to make observations. A motor vehicle, occupied by two youthful appearing male individuals, parked in front of the store. Investigators observed the youthful appearing driver exit the vehicle and enter the licensed premises.
3. Shortly thereafter, Investigators observed the same individual exit the premises in possession of a 12-pack of Smirnoff Ice and a brown bag containing what appeared to be alcoholic beverages. The alcoholic beverages were later identified as a 10-pack of Dr. McGullicuddy's nips, .750 Smirnoff Red, White, and Berry vodka, and three boxes of Beatbox wine.


4. Investigators approached the individual, identified themselves and requested proof of age to lawfully purchase and/or possess alcoholic beverages.
5. Underage #1, actual date of birth 3/04/2004 (age 20), stated to Investigators that he had previously worked at this store and was known to the clerk, so he was not asked for any identification.
6. Investigators entered the licensed premises and spoke to the clerk who sold the alcoholic beverages to Underage #1. He admitted he did not ask Underage #1 for any identification since he knew him.
7. Investigators informed the clerk of the violation and that a report would be submitted to the Chief Investigator for further action.
8. Kushan Patel, Licensee, appeared at the Commission hearing along with Kosha Patel, Manager of Record.
9. The Licensee has held a license under M.G.L. c. 138, § 15 since 2023.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age (1 Count). Therefore, the Commission **SUSPENDS the license for a period of one (1) day which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.**


