DECISION

NARAYANDAS CORPORATION D/B/A WEBSTER SQUARE PACKAGE STORE
1014 MAIN ST
WORCESTER, MA 01603
LICENSE#: 1508-00315
VIOLATION DATE: 9/28/2018
HEARD: 11/13/2018

Narayandas Corporation d/b/a Webster Square Package Store (the "Licensee" or "Super Liquors") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, November 13, 2018, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an Illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

1. Investigator Di Cicco's Investigative Report; and
2. Licensee Stipulation of Facts; and
3. Photocopy of Fraudulent Identification.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FINDINGS OF FACT

1. On Friday, September 28, 2018, Investigators Keefe and Di Cicco ("Investigators"), along with Worcester Police Officer Patrick Harrington from the Worcester Police Department Alcohol Enforcement Unit, conducted an investigation of the business operation of Narayandas Corporation d/b/a Webster Square Package Store to determine the manner in which its business was being conducted.
2. At approximately 10:30 p.m., Investigators observed a youthful appearing individual enter the licensed premises. Moments later, Investigators observed this same individual exit the store in possession of alcoholic beverages, three (3) bottles of wine.


3. Underage #1 presented to Investigators a fraudulent Arizona driver's license that she had used to purchase the alcoholic beverages.
4. Later in the evening Investigators entered the licensed premises and spoke to the staff on duty. Investigators reviewed the surveillance video with the employees who were working, and pointed out the Underage Patron to them.
5. Investigators informed the employees of the violation and that a report would be filed with the Chief Investigator for review.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an Illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Therefore, the Commission **issues a WARNING.**


