#### **DECISION**

P AND N INC. D/B/A LINCOLN DISCOUNT LIQUORS 560 LINCOLN STREET WORCESTER, MA 01605 LICENSE#: 00239-PK-1508 VIOLATION DATE: 6/13/2024

P and N Inc. d/b/a Lincoln Discount Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 17, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple & Fleming's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Temple & Fleming's Minimum Purchase Age Compliance Check Field Report, 6/13/2024;
- 2. ABCC Form 43, License Transfer Approval, 9/30/1993;
- 3. Licensee's Stipulation of Facts.

#### FINDINGS OF FACT

- 1. On Thursday, June 13, 2024, at approximately 6:01 p.m., Investigators Temple and Fleming ("Investigators") conducted a compliance check at P and N Inc. d/b/a Lincoln Discount Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce Modelo beer, for three dollars and ninety-nine cents (\$3.99). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1993 with no prior violations.

### **CONCLUSION**

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
