NOTICE OF SUSPENSION

After a hearing on April 19, 2011, the Commission finds Salty Dog Saloon, Inc dba Salty Dog in violation of Massachusetts General Laws c. 138, §34C.

The Commission suspends the licensee's license for a total of seven (7) days to be served. The suspension shall commence on Wednesday, August 17, 2011 and terminate on Tuesday, August 23, 2011. The license will be delivered to the Local Licensing Board or its designee on Wednesday, August 17, 2011 at 9:00 A.M. It will be returned to the licensee Wednesday, August 24, 2011.

You are advised that pursuant to the provisions of M.G.L. c.138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form. All checks must be certified and accompanied by the enclosed form, which must be signed by a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

Salty Dog Saloon, Inc. dba Salty Dog (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, April 19, 2011, regarding an alleged violation of M.G.L. c.138, §34C (1 count). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Brad Doyle's report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts;
- 2. Investigator Brad Doyle's Report; and
- 3. Box of Confiscated ID's.

There is one (1) tape of this hearing.

FACTS

- On Saturday, December 18, 2010 at approximately 12:45 a.m., Commission Investigators Kujawski and Doyle observed the business operation of Salty Dog Saloon, Inc. dba Salty Dog.
- 2. The investigators noticed a youthful looking male in possession of an alcoholic beverage.
- 3. The investigators identified themselves to the male patron and asked him for identification. He was sixteen (16) years old.
- 4. The male patron told the investigators he was not asked for identification prior to being served.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated M. G. L. c. 138, §34C. Therefore, the Commission suspends the licensee's license for a period of seven (7) days.

Salty Dog Saloon, Inc. dba Salty Dog (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, April 19, 2011, regarding an alleged violation of M.G.L. c.138, §69 (1 count). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Dennis Keefe report.

- 1. Licensee's Stipulation of Facts; and
- 2. Investigator Dennis Keefe's Report.

There is one (1) tape of this hearing.

FACTS

- On Saturday, December 18, 2010 at approximately 12:40 a.m., Commission Investigators Keefe, Bailey, Kujawski and Doyle investigated the business operation of Salty Dog Saloon, Inc. dba Salty Dog.
- 2. Investigators observed one male patron stagger from the front door to the far rear of the establishment.
- 3. While standing at the bar, his head was moving up and down and his eyes were closed for periods of four (4) or five (5) seconds at a time.
- 4. The investigators determined the man was intoxicated and that the bartender had the ability to make the same determination.
- 5. At 1:30 a.m., the male patron remained at the bar for about four (4) minutes and was then served two (2) Bud Light beers.

CONCLUSION

Based on the evidence, the commission finds the licensee violated M.G.L. Ch. 138 §69 (1 count). The Commission suspends the license for five (5) days of which five (5) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission regulations occur.
