NOTICE OF SUSPENSION

After a hearing on December 13, 2022, the Commission finds Shri Mahadev Corp. d/b/a One Stop Beer & Wine violated M.G.L. Ch. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). The Commission suspends the license for a period of two (2) days to be served.

The suspension shall commence on Monday, March 27, 2023, and terminate on Tuesday, March 28, 2023. The license will be delivered to the Local Licensing Board or its designee on Monday, March 27, 2023, at 9:00 A.M. It will be returned to the licensee on March 29, 2023.

You are advised that pursuant to the provisions of M.G.L. c.138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

DECISION

SHRI MAHADEV CORP. D/B/A ONE STOP BEER & WINE 147 HIGHLAND ST. WORCESTER, MA 01609

Shri Mahadev Corp. d/b/a One Stop Beer & Wine (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, December 13, 2022, regarding an alleged violation of M.G.L. Ch. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Binienda's report.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Thursday, September 29, 2022, at approximately 8:50 p.m. Investigators Gould and Binienda ("Investigators") inspected the business operation of Shri Mahadev Corp. d/b/a One Stop Beer & Wine.
- 2. While outside the licensed premises, Investigators observed two youthful appearing female individuals enter the establishment and shortly thereafter exit the premises in possession of what appeared to be alcoholic beverages.

- 3. Investigators approached, identified themselves and asked to see proof of legal age to possess alcoholic beverages.
- 4. Underage #1, actual date of birth 11/17/2003 (age 18), informed Investigators she used a fraudulent Connecticut driver's license to purchase the alcoholic beverages.
- 5. Investigators secured the fraudulent identification and the following alcoholic beverages as evidence: one 1.5-liter bottle of Barefoot Pinot Grigio wine, three boxes of Beatbox wine, and one 1.5-liter bottle of Barefoot Pink Moscato wine.
- 6. Investigators entered the licensed premises and spoke to the clerks on duty. The clerk who made the sale stated that she had scanned Underage #1's identification and the scanner indicated she was over 21 years of age.
- 7. Investigators informed the clerk of the violation and that a report would be filed with the Chief Investigator for further action.
- 8. The Licensee has been licensed under M.G.L. c. 138, § 15 since 2020 with one prior violation.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. Ch. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Therefore, the Commission suspends the license for a period of two (2) days.
