

Project Location Route 143 (Old North Road) in Worthington (From Peru Town Line to Cold Street)





SCALE: 1" = 3000'



- Pavement rehabilitation and related work on approximately 3.9 miles of Route 143 (Old North Road) from the Peru Town Line to Cold Street in the Town of Worthington.
- Other related work includes: upgrading non-compliant guardrail and end treatments as required; removing ledge within clear zones and sight lines; stormwater improvements including culvert replacements and cured-in-place pipe lining; box culvert construction; retaining wall construction; installation of milling mulch beneath guardrail and at eroded shoulders; wetland restoration and replication; installing final pavement markings, temporary traffic control; replacing signs, removing and resetting signs; implementing all safety controls and signing required for the necessary work zones; and other incidental items of work as determined by the Engineer.
- No bridge work is proposed to be included in this project.



Overview Purpose & Need/Traffic Impacts

Purpose & Need

- Existing pavement has degraded to a poor level and requires full depth reconstruction. This will improve the pavement serviceability, condition, and roadway safety.
- Widening of the roadway is proposed for improved bicycle, pedestrian, and vehicular safety.
- Existing guardrail and drainage structures need to be upgraded.

Traffic Impacts

- Lane closures will have impacts to the overall traffic pattern with one lane of alternating traffic in each direction. A detour is proposed while the box culvert is being constructed and the roadway is closed.
- The proposed schedule for operations shall be the standard 8-hour day, 5-day week, unless otherwise authorized by the Engineer and with certain exceptions for holidays.
- Construction will take approximately four years to complete.
