DECISION

MARMINA THE WONDEROUS INC. D/B/A HOTSHOT 60 SOUTH STREET WRENTHAM, MA 02093 LICENSE#: 90409-PK-1514

Marmina The Wonderous Inc. d/b/a Hotshot ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 20, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Smith & David's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Smith & David's Minimum Purchase Age Compliance Check Field Report, 5/21/2024;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved 11/21/2022;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Tuesday, May 21, 2024, at approximately 6:05 p.m., Investigators Smith and David ("Investigators"), conducted a compliance check at Marmina The Wonderous Inc. d/b/a Hotshot.
- 2. An underage operative working under the supervision of Investigators purchased an alcoholic beverage, one 25-ounce Bud Light beer, for two dollars (\$2.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2022 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
