Rate includes Vehicle, Driver and Helper.

Within a 20 mile radius of origin point-----\$85
Each additional 10 miles or fraction thereof-----\$10

Time is computed from the time vehicle and helpers report at the original point of loading until the completion of unloading the last load at final destination, less time spent for meals or vehicle breakdown, plus an added charge for each vehicle and all helpers used, to cover running time which shall not be assessed more than once during any one day to the same shipper for the same vehicle as stated below:

UP TO AND INCLUDING 15 MILES-----	\$20.00

Each Extra Man.....\$25 per hour

2 hours minimum and Travel charges applies to the service described above.

Furniture Deliver:

The term "Furniture Delivery" as used in this tariff means: Transportation of maximum 3 pieces of furniture or household goods from one location such as storage facility, house or apartment to another. No travel charges are applied in this case. Rate includes Truck, Driver and Helper.

Within 20 miles radius.....\$85

Each 10 miles or fraction thereof.....\$10

Travel charges:

Time is computed from the time truck and helpers report at the original point of loading until the completion of unloading the last load at final destination, less time spent for meals or vehicle breakdown, plus an added charge for each vehicle and all helpers used, to cover running time which shall not be assessed more than once during any one day to the same shipper for the same vehicle as stated below:

Based on the distance between the original point of loading and final point of unloading in accordance with odometer readings

Up to and including **15 miles**.....\$20

Each **10 miles** or fraction thereof.....\$5
