Juvenile: Due to the conversion from Juris to Masscourts, FY2012 figures for Essex and Norfolk Counties were not reported for CHINS petitions, *Permanency Hearings*, *Show Cause Hearings*, and *Jury Cases*. In FY2013, the reporting unit for juvenile delinquency and youthful offender cases was changed from charges to cases.

Probate & Family: From 2005 to FY2011, *Probate* incuded *guardianship-incapacitated* case types. Beginning in FY2012, *Guardianship* includes all guardianship case types. Prior to FY2012, *Guardianship* included guardianship-minor case types, only.

Child Welfare and Adoption includes: *Child welfare* cases in the Probate and Family Court and *young adult permanency hearings* and *adoption* cases in the Juvenile Court.

Restraining Orders: From FY2011 to FY2014 this category included *harrassment orders* in the District Court.
