## Introduction Termination Retirement Transmittal to the Commission

### Who should use the Termination Retirement Transmittal to the Commission?

This form is to be used by Retirement Board Members to certify to the Public Employee Retirement Administration Commission (PERAC) that the Retirement Board has received an application for a termination retirement pursuant to G.L. c. 32, § 10(2), has voted to approve the application, and pursuant to G.L. c. 32, § 21(1)(d) the Board is forwarding its decision to PERAC for review.

When PERAC approves a Retirement Board's decision to grant a termination retirement application, PERAC will use the *Termination Retirement Transmittal to the Commission* to certify its approval. No Termination Retirement Allowance can be paid until PERAC approval is granted and the calculation of the allowance is approved.

# Should the completed Termination Retirement Transmittal to the Commission and all of the related attachments be faxed to PERAC?

The *Transmittal* and all of the related attachments should be transmitted to PERAC via US Mail. **Due to confidentiality considerations, these documents MUST NOT be transmitted via fax machines.** 

# What are the attachments that must accompany this form when it is submitted to **PERAC**?

- The Employer's Statement in Connection with a Termination Retirement Application
