**RE:** *All Provider Manuals (Revised Appendix C)*

This letter transmits an updated Appendix C: Third-Party-Liability Codes for all provider manuals. This appendix contains a list of third-party-liability (TPL) coverage-type codes including carrier names and addresses, where applicable. The appendix has been updated and reorganized to include Medicare and Casualty Payer carrier codes sections. The information is up to date as of September 1, 2014.

For members who have other insurance, the MassHealth Eligibility Verification System (EVS) reports the coverage type, carrier code, and policy number of the insurance listed on file. Appendix C of the MassHealth *All Provider Manual* lists the names and addresses of other insurance carriers in numeric order by carrier code so that you can bill that insurance carrier before billing MassHealth.

If you receive written evidence (for example, an explanation of benefits or a letter from an employer) that a member does not have the insurance identified on EVS, has different insurance than what is reported on EVS, or no longer has insurance coverage, please mail or fax the information to the following address. If a member has a new or different insurance not identified on EVS, please fill out a third-party-liability (TPL) indicator form and send it to the address or fax number below. You can find the TPL Indicator Form in the online Provider Library at the link below.

### Important Notice about the Use of Carrier Codes

There are five carrier code sections in Appendix C, as follows.

1. **Commercial.** This is the section that most providers will use. Providers should use these codes on claims for members who have commercial insurance.
2. **Medicare.** Providers should use these on claims for members who have original Medicare Part A (Hospital Insurance) or Part B (Medical Insurance) coverage or both.
3. **Medicare Advantage Plan (Medicare Part C).** Providers should use these on claims for members enrolled in a Medicare Advantage Plan. (Members must be enrolled in Part A and Part B (Original Medicare) before choosing a Part C (Medicare Advantage) plan.)
4. **Medicare Part D.** These codes are for pharmacy use only. Other providers should never use these codes on a claim.
5. **Casualty Payer (formerly PIP).** Providers should use these codes for reporting Casualty Payer payments of claims.

**Please Note:** We will update Appendix C on our website as needed to keep it current.

This appendix contains a list of third-party-liability (TPL) coverage-type codes and a numeric list of carrier codes, including carrier names and addresses. For members with a temporary MassHealth card, any applicable TPL coverage-type and carrier codes are printed on the card itself.

#### How Appendix C Is Organized

There are five sections to the carrier code file. The first section contains commercial carrier codes. This is the section that most providers will use. Providers should use these codes on claims for members who have commercial insurance. The second section contains Medicare carrier codes. Providers should use these on claims for members who have original Medicare Part A (Hospital Insurance) or Part B (Medical Insurance) coverage or both. The third section contains Medicare Advantage carrier codes. Providers should use these codes on claims for members who have Medicare Part A and B, and are enrolled in a Medicare Advantage Plan (Part C). The fourth section contains Medicare D carrier codes. These codes are for pharmacy use only. Other providers should never use these codes on a claim. The fifth section contains Casualty Payer (formerly PIP) carrier codes. Providers should use these codes for reporting Casualty Payer payments on claims.

The Eligibility Verification System (EVS) in MMIS provides the insurance information for the member. Please check EVS before submitting your claim. Casualty coverage is not considered health insurance; therefore, Casualty Payer information is not available on EVS. Refer to the applicable billing guide or companion guide for instructions on using EVS. These guides are available on the web at [www.mass.gov/masshealth](http://www.mass.gov/masshealth).

#### I. Third-Party-Liability Coverage-Type Codes

The following is a list of TPL coverage-type codes that identify the type of insurance a member has. If you use the MassHealth EVS Automated Voice Response (AVR) system, you will be given one of the following TPL coverage-type codes.
