#### 2014 Results

The number of employers taking part in the event grew from the first to second year, and the number of consumer interviews that were planned and executed during the event grew substantially. Through August 2014, 109 MRC consumers have been placed into competitive employment as a direct result of the MRC/OFCCP/MCB 2014 Federal Hiring Event. Of these, 79 have achieved a Successful Employment Outcome, holding employment for 90 days or more.

> The current average wages for consumers employed through the MRC Federal Hiring Event are \$13.81, and the average work hours are 29 hours per week.

#### **Consumer Feedback**

The MRC conducts annual surveys of Federal Hiring Event consumers, staff, and participating contractors to obtain feedback for planning and management purposes. Survey results have shown high levels of satisfaction and enthusiasm from all three of these groups over the first two years of the event.

In 2014, 92% of surveyed consumers were satisfied with the hiring event and with their interviews, with the great majority reporting that they were "very satisfied" overall. A majority of surveyed MRC consumers reported that they felt adequately prepared for their interviews.

### **Program Description**

The MRC/Office of Federal
Contracts Compliance Program
(OFCCP) Federal Hiring Event
brings Vocational Rehabilitation
consumers and federal contractors
together in one space. The event
provides consumers with
opportunities for competitive
employment, and federal
contractors with access to qualified
applicants. The first Federal Hiring
Event took place in 2013, and its
clear value and success led to the
development of an annual event.

The MRC's Job Placement and Employment Specialists work with the OFCCP to recruit federal contractors for the event. MRC counselors identify consumers with interests, strengths and skills suited to the event. The MRC prepares these consumers for successful interviewing and preparation prior to the event.

In 2014, the Massachusetts
Commission for the Blind (MCB)
also took part, and three
simultaneous hiring events took
place across the Commonwealth.
With continued success, this
initiative can grow to include more
regional partners and assist a
wider group of consumers and
federal contractors. The Federal
Hiring Event offers a viable model
for innovative VR agency
collaboration with employers.
