RE: Groundfish Disaster Aid Pre-qualification Status and Notice of Appeal Period

The Massachusetts Division of Marine Fisheries (DMF) is writing to inform you that based upon your application for groundfish disaster assistance as a shoreside business owner you <have/ have not> been pre-qualified for inclusion in Phase 2 of the Groundfish Disaster Economic Assistance Program.

Shoreside business owners that applied are being pre-qualified to receive a tiered flat rate payment based on meeting the following criteria:

Higher Flat Rate

Shoreside business owner was able to document in any one year during 2009-2013:

- 1) at least \$32,500 of total business income was generated by the Massachusetts commercial groundfish industry;
- 2) at least 30% of total business income was generated by the Massachusetts commercial groundfish industry; and
- 3) the business continues to actively support the Massachusetts commercial groundfish industry.

Lower Flat Rate

Shoreside business owner was able to document a more than nominal amount of business income was generated by the Massachusetts commercial groundfish industry but did not meet either the \$32,500 or 30% filters established for a higher flat rate. Additionally, the business continues to actively support the Massachusetts commercial groundfish industry.

In the table below, you will find further details regarding DMF's decision to prequalify you based on the information you submitted with your application and upon further DMF request. If you believe there was a technical error in the pre-qualification data, you may submit a written
