JOINT PETITION FOR APPROVAL OF NEGOTIATED INTERCONNECTION AGREEMENT BETWEEN GRANBY TELEPHONE COMPANY AND VERIZON WIRELESS

Granby Telephone Company ("LEC") and Bell Atlantic Mobile of Massachusetts Corporation, Ltd., and Pittsfield Cellular Telephone Company, each d/b/a Verizon Wireless ("CELL") do by this petition request that the Massachusetts Department of Telecommunications and Energy review and approve the attached Interconnection Agreement pursuant to Sections 252(a)(1) and 252(e) of the Telecommunications Act of 1996 47 U.S.C. §§ 252(a)(1) and 252(e) (the "Act"). In support of their request, the parties state as follows:

1. The Agreement was arrived at through good faith negotiations between the parties as contemplated by Section 252(a) of the Act and provides for interconnection as addressed in Section 251 of the Act.

2. Pursuant to Section 252(e)(2), the Commission may only reject a negotiated Agreement if it finds that (1) the Agreement discriminates against another carrier or (2) implementation of the Agreement would not be consistent with the public interest, convenience and necessity. 3. LEC will make the Agreement available to any other telecommunications carrier operating within its territory. Other carriers are also free to negotiate their own terms and conditions pursuant to the applicable provisions of the Act. For this reason, the Agreement is not discriminatory.

4. In addition, implementation of the Agreement is consistent with the public interest because it will promote competition and enhance CELL's ability to provide Massachusetts telecommunications users with a competitive alternative for Commercial Mobile Radio Services.

5. In accordance with Section 252(e)(4) of the Act, the Agreement will be deemed approved if the Commission does not act to approve or reject the Agreement within 90 days from the date of this submission.

6. A copy of the executed Agreement, designated as Exhibit 1, is attached hereto and is incorporated into this petition by reference.

WHEREFORE, LEC and CELL respectfully request that the Commission approve the attached Interconnection Agreement under Section 252(e) of the Act as expeditiously as possible.
