
Letter Agreement between One New Boston Nominee Trust and MD Holistics Inc.

One New Boston Nominee Trust and James D. Berish, Trustee (LESSORS) agree to lease to MD Holistics Inc., Mr. Joseph Mullen and Mr. Drew Mullen (LESSEES), One New Boston Drive, Unit 1, Canton, MA 02021 in significantly similar form and terms as the previous Lease Agreement and Amendment between the parties dated March 23, 2016 and June 30, 2016 respectively upon LESSEES satisfactory approvals from the Town of Canton.


Such agreement shall only extend up to December 9, 2016 at which time if there is no fully executed Lease Agreement between the parties, then such parties will have no obligations to each other.

In the event LESSOR finds an interested party to lease the premises prior to December 9, 2016, then LESSOR shall provide notice to the LESSEES (MD Holistics, et al) by email of its intent to lease the above mentioned premises. If LESSEES fail to sign a mutually acceptable lease agreement within five days of such notice then LESSORS shall have the right to lease the premises without any further obligation or commitment to the LESSEES.

SECTION D: LOCAL COMPLIANCE

Describe how the Corporation has ensured, and will continue to ensure, that the proposed RMD is in compliance with local codes, ordinances, and bylaws for the physical address(es) of the RMD.

The Corporation has thoroughly reviewed the medical marijuana bylaws for the town of Canton. On April 12, 2016 MDH appeared before the Canton Board of Selectmen. Two weeks later on April 26, 2016 the Canton Board of Selectmen voted to issue MDH a letter of non-opposition to operate an RMD in Canton at One New Boston Drive. MDH thoroughly reviewed all local codes, ordinances and bylaws as they apply to the physical address of the proposed RMD and in consultation with consultants and advisors determined that the proposed site is in compliance with said codes, ordinances, and bylaws pursuant to local permitting via the Canton Zoning Board of Appeals. MDH will work with the appropriate authorities in Canton in order to secure the necessary permits (including a Special Permit and Variance for Use) to begin operations at the proposed site. MDH will ensure compliance with local codes, ordinances, and bylaws for the physical address of the RMD through a comprehensive compliance program that will include, but not be limited to, instituting policies and procedures that comply with said regulations and continuously soliciting input from all local stakeholders including local law enforcement authorities.
