	<p>OUT-OF-STATE LICENSE</p> <ul style="list-style-type: none"> ● Your out-of-state License with photo may also be used to prove date of birth ● If you do not have your out-of-state License, or if the License is from Canada, Mexico, or a U.S. territory (including Puerto Rico), you will need a certified Driving Record – Not more than 30 days old ● If you do not have the out-of-state License OR if the out-of-state License does not have a photo, an acceptable photo ID from the <i>Acceptable Identification Documents</i> list is required

	<p>PAYMENT of \$115</p> <ul style="list-style-type: none"> ● There is an additional \$15 fee to add Motorcycle privileges to a Class D License ● Payable by cash, check (payable to MassDOT), money order, or credit/debit card
