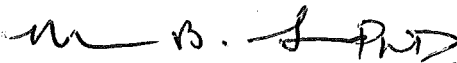

Board Business:

1. At 9:03 a.m., the meeting was called to order.
2. Dr. Jacobo reviewed evacuation instructions.
3. On a motion by Dr. Sanchez, seconded by Dr. Hudgins, the Board voted to approve the Board Meeting and Executive Session minutes for the March 10, 2017 meeting. All in favor with Dr. Scherer abstaining.
4. The Board reviewed correspondence from Dr. Randi Dorn at William James College. The Board will issue a response signed by co-chairs requesting that Dr. Dorn refer to previous responses to questions presented to the board.
5. Discussed Dr. Lugo-Estrada applicant. The board, by unanimous consent, agreed to invite the applicant to meet with the board to discuss waiver request and ethical reference reservations.
6. Discussed applicant, Dr. Baalbaki. Hudgins recuses. The board agreed, by unanimous consent, to grant a waiver request, but determined that supervised experience criteria were not met. Dr. Hudgins took no part in the discussion of or vote upon this matter.
7. Discussed applicant, Dr. Stufflebaum. The board agreed, by unanimous consent, to approve her supervised position as meeting criteria for HSP.
8. Discussed applicant Dr. Grima. The board determined, by unanimous consent, that the applicant needed additional coursework (ethics, cognitive affective, social, and cultural basis of behavior).
9. Discussed applicant Dr. LePage. The board agreed, by unanimous consent, to accept the proposed CE course.
10. Attorney Kelley provided board counsel report.

At 10:06 a.m., on a motion by Dr. Scherer, and seconded by Dr. Glover, all were in favor, the Board voted to enter into closed session for the purpose of conducting investigative conferences, pursuant to G. L. c. 112, § 65C, for: PY-2016-000505-IT-ENF. Dr. Sanchez took no part in the discussion of or vote upon this matter.

At 11:11 a.m., on a motion by Dr. Sanchez, seconded by Dr. Carey, the board voted to enter and exit open session and to enter executive session for the purposes of complying with the public record law and discuss medical record information pursuant to G. L. c. 30A, § 21(a)(7); G. L. c. 66, § 10; G. L. c. 4, § 7, ¶ 26(c). Following a roll call vote, all in favor, the motion passed.
13. At 11:45 am, on a motion by Dr. Glover and seconded by Dr. Sanchez, the Board voted to exit executive session and enter open session. Following a roll call vote, all in favor, the motion passed.

15. PY-2016-000770-INT-ENF: on a motion by Dr. Glover, seconded by Dr. Scherer, the board voted to dismiss the complaint. All in favor.
16. PY-2016-000271-INT-ENF: on a motion by Dr. Glover, seconded by Dr. Scherer, the board voted to dismiss the complaint. All in favor.
17. PY-2016-000161-INT-ENF: on a motion by Dr. Glover, seconded by Dr. Scherer, the board voted to dismiss the complaint. All in favor.
18. At 12:05 pm, the board recessed for lunch.
19. At 1:00 pm, the board reconvened into open session.
20. At 1:00 pm, on a motion by Dr. Scherer, seconded by Dr. Hudgins, the board voted to move into closed session for investigative conference with PY2016-000505-IT-ENF. All in favor. Attorney Yellen present with licensee. Dr. Sanchez took no part in the discussion of or vote upon this matter.
21. At 2:20 p.m., on a motion by Dr. Glover, seconded by Dr. Scherer, the Board unanimously voted to exit closed session, enter open session and thereupon to adjourn.
