Board Business:

1. At 9:15 a.m., the meeting was called to order by Dr. Jacobo.
2. Dr. Jacobo reviewed evacuation instructions.
3. On a motion by Dr. Bistis, seconded by Dr. Anderson with suggested corrections to the spelling of her name and degree credentials, the board meeting minutes were unanimously approved from the September 15th meeting.
4. There was no correspondence.
5. Discussed Dr. Reeb applicant. On a motion by Dr. Glover, seconded by Dr. Scherer, the board, voted unanimously to request applicant make up 16 remaining CEU credits to renew their license.
6. On a motion by Dr. Bistis, seconded by Dr. Scherer, the board voted and agreed unanimously to approve the administrative review of applicants.
7. At 9:27 am on a motion by Dr. Scherer, and seconded by Dr. Bistis, all were in favor following a roll call vote, the Board voted to enter into executive session for the purpose of discuss medical record information and to comply with the public record law, pursuant to G. L. c. 30A, § 21(a)(7); G. L. c. 66, § 10; G. L. c. 4, § 7, ¶ 26(c). At 9:40 Dr. Bistis moved, seconded by Dr. Hudgins, to exit executive session and enter open session. Following a roll call vote, all in favor, the motion passed.
8. At 9:40 am, Dr. Bistis moved, and was seconded by Dr. Scherer, to enter into closed session for the purpose of conducting investigative conferences, pursuant to G. L. c. 112, § 65C, all in favor.
9. At 10:28 am, on a motion by Dr. Bistis, seconded by Dr. Scherer, the board voted to exit closed session and enter open session. All were in favor.

10. No board counsel report.

11. 2017-000662-IT-ENF: on a motion by Dr. Bistis, seconded by Dr. Hudgins, the board voted unanimously to dismiss the complaint.

12. 2017-000884-IT-ENF: on a motion by Dr. Bistis, seconded by Dr. Hudgins, the board voted unanimously to invite the licensee to meet with the board during investigative conference.

13. 2017-000909-IT-ENF: on a motion by Dr. Bistis, seconded by Dr. Hudgins, the board voted to table the review in order to seek additional information.

14. 2017-000636-IT-ENF: The licensee was not present for the conference and has not been in contact with the Board to determine their participation. On a motion by Dr. Bistis, seconded by Dr. Hudgins, the board voted unanimously to send a certified letter to the license requesting their appearance or risk being forwarded to prosecutions.

15. At 10:32 p.m., on a motion by Dr. Scherer, seconded by Dr. Bistis, the Board unanimously voted to adjourn.
