EOHHS is reopening the Competitive Integrated Employment Services (CIES) procurement in order to secure additional vendors or programs to fill geographical and program needs. Vendors that are not currently qualified under CIES may apply at this time. Vendors who are currently qualified and under contract with EOHHS will retain their status and need not reapply for any reason. Please note that at this time, DTA is interested in new vendors.

If you are a Provider who has previously been approved for CIES with any of the following four agencies, you do not need to submit another application. The four (4) agencies are:

- Massachusetts Commission for the Blind (MCB)
- Massachusetts Rehabilitation Commission (MRC)
- Department of Developmental Services (DDS)
- Department of Transitional Assistance (DTA)

**If you are a Provider currently providing CIES services to the Department** (**DTA**) **in an area and choose to expand services to another area or areas**, you must notify Kimberly Rowe-Cummings, Director, Employment Services Program, <u>in writing at the address given below</u> identifying the location(s) where you wish to expand your CIES services. You <u>do not have to file an application</u> for this RFR. However, you must prepare and submit a CIES Business Plan and a CIES Provider Overview.

If you are a Provider that has been approved for CIES services for one of the four Departments listed above and wish to now provide CIES services to DTA, you must notify Kimberly Rowe-Cummings, Director, Employment Services Program, in writing at the address given below identifying the location(s) where you wish to expand your CIES services. You do not have to file an application for this RFR. However, you must prepare and submit a CIES Business Plan and a CIES Provider Overview.

Any other interested Vendor must submit a complete application for the **RFR for approval for CIES services.** Applications are reviewed and scored by a team. Refer to the RFR for details on scoring.

Similarly, requests by current approved Vendors to provide CIES services in an expanded area, does not guarantee that such requests will be approved. All requests are determined by funding and allocated slots needed for specific locations.
