Purpose:	To notify Local Workforce Development Boards, One-Stop Career Center Operators and other local workforce partners of the Massachusetts Community Transportation Coordination Conference / MassDOT's Innovation & Mobility Exchange, being held April 10 th and 11 th at The DCU Center, 50 Foster Street, Worcester.
Background:	Registration for the 2018 conference is now open. In order to better integrate mobility management with other transportation initiatives, the 2018 Massachusetts Community Transportation Coordination Conference will be held in conjunction with MassDOT's Innovation and Mobility Exchange. With over 60 sponsors and exhibitors, the conference will have countless opportunities to meet with experts, as well as interactive demonstrations and engaging displays of cutting edge technology.

The second day - April 11 - will highlight mobility management, featuring a number of panels and breakout sessions on topics relevant to improving mobility and access for seniors, people with disabilities, and low-income commuters in Massachusetts. Attendees will also have access to many general conference sessions on emerging technologies and other innovations.
