

Fiscal Year 2017 HIGHLIGHTS



INDIVIDUALS SERVED

The DMH serves individuals within the Commonwealth with the most significant and persistent mental illness.

25,639 individuals with significant and persistent mental health needs were served by the Department throughout the year. The Department has capacity for 21,000.

5,749 individuals received case management.

Individuals were enrolled in homeless support services through the DMH Homeless Outreach Team, St. Francis, Pine St. Inn, Boston Public Health Commission, Vinfen, and Eliot Community Human Services.

At the start of FY17, the DMH competitive employment rate was approximately 18%. By the end of the fiscal year, the rate **increased to 21%.**

67 facilities were licensed by DMH in FY17, with a capacity of 2,776 beds.

12,194 individuals were referred to DMH by the Juvenile, District, and Superior Courts in FY17.

33 Jail Diversion Programs (JDP) grants were awarded in FY17.

100 (approximately) communities were served by JDP trained entities in FY17.

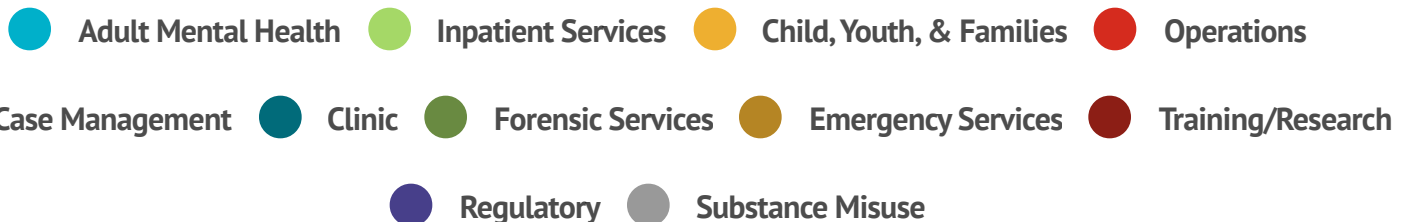
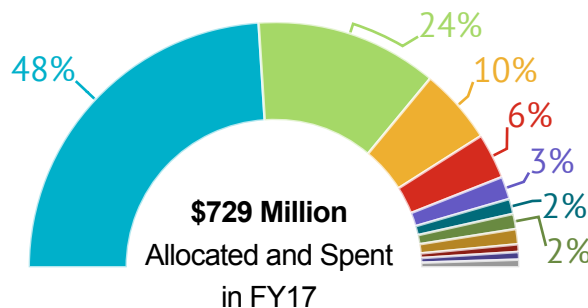
