The context of this proposal will be a comprehensive outline of Wildlife Services (WS) projected activities that should be conducted to reduce predation on 866-4USDA WS shorebird populations at Monomov National Wildlife Refuge. 413-253-2403

During the 2016 nesting season, WS deemed five (5) wildlife species as "major predators". These species were American crow, Eastern covotes, herring gull, great black-backed gull and common grackle. These species have been labelled major predators because of confirmed predation. Each species has been responsible for shorebird predation at various times of the year and will require different management practices.

In previous years, WS has controlled all of the above listed species by use of firearms. Common grackles have been also controlled with decoy traps that prove to be very effective when WS is on site to check traps on a daily basis. During the 2017 nesting season, WS would like to modify the current design of the decoy traps used in the past. This modified design will allow for the decov traps to remain set while WS is not on site and checked on a weekly or biweekly basis depending on the situation. Eastern coyotes have also been trapped with live traps which has been effective along with shooting.

There are many options to control American crows. Though there has only ever been one method used on Monomov NWR, shooting with firearms, other options include the use of DRC-1339, box trapping and the use of the newly MA registered aversive agent called Mesurol. This agent acts as a taste aversion for American crows and is used in a manner similar to DRC-1339. Prebait eggs are placed out in mock piping plover exclosure until there is 100% uptake and then baits are injected with mesurol. If any one of these other methods is of interest for the 2017 nesting season, please feel free to call the WS state office and it can be explained further.

WS will also assist Monomov NWR in renewing or modifying their USFWS depredation permit in order to conduct all listed activities in 2017.

All of the above activities and options listed are what WS can do to show a positive impact to nesting success of shorebirds on Monomoy NWR. Every year brings different weather patterns, habitat changes and predator activity and activities that need to be conducted to alleviate predation can change. This work plan is written to have flexibility to allow changes during the nesting season.

For the 2017 nesting season, as in 2016, WS plans to conduct activities that have been advantageous to nesting success at Monomov NWR. The attached financial plan allows for live trapping and sharp shooting (with shot gun and rifle) of predators present on Monomov NWR. WS man hour cost can change due to salary difference, specialized equipment on hand and times of day working.

At your request, our office has developed this proposal for a program to conduct direct control of both avian and mammalian predators at Monomov NWR. The cost for a Cooperative Service Agreement (CSA) providing six months of control, consisting of a minimum of 500 man hours will be for a total of \$24,800. These visits can be used for any of the activities; trapping, shooting or toxicant applications. Wildlife Services will schedule control visits and may increase or decrease visits during the agreement depending on predator presence and activity. Please see the attached financial plan.

Wildlife Services will also provide Monomoy NWR with a report of all activities conducted within the 2017 nesting season to include a qualitative assessment of how effective the effort was, unanticipated challenges that were encountered during the 2017 nesting season and preliminary recommendations for future efforts.

The start date for the proposed CSA drafted is 1 April, 2017 until 31 August, 2017. This date can be changed to any date agreed upon by both WS and Monomoy NWR.

This letter is in response to your January 17, 2017 memorandum, electronically transmitted to Susi von Oettingen of this office, in which you requested our review of the Predator Management Proposal on Monomoy National Wildlife Refuge. The memorandum included a proposal from the U.S. Department of Agriculture, Wildlife Services (Wildlife Services) to Ms. Cheryl Horton of the U.S. Fish and Wildlife Service, Monomoy National Wildlife Refuge (Refuge), to selectively remove avian and mammalian predators from the Refuge, and a proposal from Brian Beals Predator Control to locate and remove denning eastern coyotes (*Canis latrans*). The proposed predator management will serve as off-site mitigation for applicants receiving certificates of inclusion under the Massachusetts Division of Fisheries and Wildlife's (MADFW) Habitat Conservation Plan for Piping Plover (*Charadrius melodus*) (HCP). According to sections 5.2.2.1 and 5.2.2.3 of the HCP, the U.S. Fish and Wildlife Service has the opportunity to review and approve site-specific mitigation plans or proposals.

We completed our review of the predator management proposal based on criteria outlined in HCP Table 4-3: Summary of Selective Predator Management Site Selection and Implementation (page 4-10). We determined that the predator management proposal meets all of the site selection criteria in HCP Table 4-3 as follows: (1) Wildlife Services identified American crows (*Corvus brachyrhynchos*), black-backed gulls (*Larus marinus*), eastern coyotes, and common grackles (*Quiscalus quiscula*) as impacting piping plover productivity when not managed; (2) the Refuge is willing to implement predator management; (3) the site has a relatively high abundance density (i.e., greater than 5 plover pairs); and (4) the predator management proposal identifies specific predators that are feasible to manage ("implementable"). Additionally, per Table 4-3 of the HCP, qualified predator management proposals include the targeted predator species,

methods, reporting, and a budget that anticipates the appropriate level of effort to successfully implement the proposal.

Background

In 2003, U.S. Fish and Wildlife Service (USFWS) at Monomov National Wildlife Refuge (NWR) requested assistance from United States Department of Agriculture (USDA) Wildlife Services (WS), to assist with the management of predators for the protection of nesting migratory seabirds and shorebirds, including state and federally listed threatened and endangered (T & E) species on South Monomoy Island in Chatham, Massachusetts. The seabird colonies are composed of common terns, least terns, state and federally endangered roseate terns, laughing gulls, herring gulls and great black-backed gulls. Nesting shorebirds included American ovstercatcher and the state and federally endangered piping plover. The colony had experienced predation from coyotes and avian species and had been under an integrated predator management program for many years.

WS assisted in predator control during the 2003 and 2004 nesting seasons. For the 2005 nesting season, the USFWS hired an experienced hunter and trapper as a seasonal biological technician. Predator management was conducted internally by USFWS staff for a number of years. In March 2010, David Brownlie, Monomoy NWR Refuge Manager, requested WS to assist with predator management for the protection of threatened and endangered species and other colonial nesting seabirds on South Monomoy Island, Chatham, MA.

Mute swans, a very large invasive exotic waterfowl species, frequent the shoreline and ponds on South Monomoy Island. These birds damage habitat by overgrazing eel grass beds in salt water and submerged and emergent vegetation in fresh and saltwater ponds. They are also highly aggressive, particularly during nesting season and significantly compete with native waterfowl for food and nesting sites. Federal agencies are required to control the spread of invasive exotic species, such as mute swans, when possible under a Presidential Order.

In 2010 WS started an agreement with USFWS to remove both avian and mammalian predators on all parts of Monomoy NWR. WS has continued doing control work through the 2017 nesting season.

Methods

During 2017, WS used different methods for control work. WS personnel were equipped with suppressed centerfire rifles and shotguns for removal of both mammalian and avian predators. WS also uses padded foot-hold, walk-in style grackle decoy traps, and box traps.

2017 Results

In 2017, WS spent approximately 475 hours over a 35 day period on the island, starting in May and ending in August. WS removed two (2) Eastern coyotes, two (2) American crows, 15 common grackles (see Figure 1), three (3) great black-backed gulls, 16 herring gulls, and three (3) mute swans. WS trapped on every visit to the island for Eastern coyotes and grackles. WS also assisted in locating humpback whales that ended up on the east side of the island. WS communicated with the refuge biologist and marine biologist as to where the whales were.

Discussion/Recommendations

WS observed a pair of Coyotes traveling back and forth from the main land during 2016 and 2017. However, they did not appear to cause a predation problem. Later in the season, during mid-July, WS saw coyote tracks on the connection, but due to weather conditions, WS never observed the coyotes. Night operations were cut short every time on the connection due to weather.

With the break at the end of South Beach, sand is filling in near North Monomoy Island and making the mud flats an easy walk at low tide for coyotes to cross back and forth. This has resulted in increased coyote activity on North Monomoy during 2016 and 2017. WS recommends initiating coyote trapping during late March or early April 2018.

Efforts to manage coyotes around the colonies and nest sites during the nesting is important and should continue with the understanding that it requires more time to remove specific individual animals that pose a threat to the birds. WS believes that problem coyotes could be removed on North Monomoy before they reach South Monomoy. Efforts to manage coyote around the colonies and nesting sites during the nesting is also important and should continue.

Managing coyote early in the year is more efficient due to less food availability and less foliage. This makes trapping and sharp-shooting easier. Conversely, efforts to remove coyotes in the late spring and summer is less efficient because high food availability makes trapping more difficult and decreased visibility due to dense foliage and high grass makes sharp-shooting difficult. Additionally, coyotes are more territorial during late winter and early spring as they set up and maintain breeding territories.

In addition to coyotes, common grackles caused predation during the 2017 nesting season. Some pairs of the piping plovers nested near dead seals washed up on the beach. The seal carcasses attracted common grackles, resulting in incidental predation on plover nests. WS recommends that if seal carcasses are located near plover nests, they be buried onsite or relocated away from the nests so that they do not attract grackles or other avian scavengers that may then locate plover nests. WS felt it was extremely difficult to monitor predation on the nesting birds due to the inclement weather during the 2017 nesting season.

WS is continuing to research different methods to deter or remove the grackles from nesting areas. One method WS is considering using would be the New York style starling trap which can be effective at capturing grackles. WS would like to set up one near Hospital Pond and another near Big Station Pond. These are areas where grackles nest. WS would set these traps before or when grackles arrive on the island in March. Figure 2 shows an example of a New York style decoy trap proposed for use. These traps are set with food used as bait, water, and shelter up and are checked regularly.

WS recommends continued monitoring for predation and maintaining current levels of predator management to protect nesting shore birds and increase nesting on the refuge. WS recommends meeting with USFWS Refuge personnel to discuss trapping for a week before the nesting birds arrive.

WS would like to thank all of the Monomoy NWR personnel involved with this project. Their contributions and cooperation now and in the future will help to make this predator control project a successful program for the enhancement of the piping plover and least tern populations in the Northeast.


