The meeting was called to order at 9:39 AM by Ms. Viens.

Read and Accept the Public Minutes from the December 5, 2018 Meeting.

After brief discussion, a MOTION was made by Ms. Dorian, seconded by Ms. Tool, to accept the minutes with changes.

The MOTION passed unanimously.

Board Counsel Report

Ms. Read introduced the topic of gender-specific naming of shops. She told the members that the existing barber regulations are silent on gender-specific naming of shops.

She told the members that shops with gender-specific names must have signage that indicates that all genders are welcome and served.

The Board asked that the issue be placed on the February agenda for discussion.

Ms. Read asked for a member to participate in a hearing on April 26, 2018. Mr. Gayzagian agreed to participate.

Executive Director Report

Mr. Bialas provided testing statistics from Pearson Vue and discussed the statistics with the Board.

Penalties for Unlicensed Practice

Ms. Read presented the issue to the members and explained that the Office of Investigation has offered an outline of how unlicensed practice can be treated.

Members discussed the proposal and options.

Several additional proposals were offered to increase the fines for first-time offenders.

A MOTION was made by Ms. Dorian, seconded by Ms. Talbot to raise the fines for unlicensed practice to \$1000 for shop owners and \$100 for individuals.

Mr. Gayzagian asked the members to consider raising the fine for individuals to \$500.

Members discussed this option.

The MOTION was amended to raise the fine for individuals to \$500.

A MOTION was made by Ms. Talbot, seconded by Mr. Nunez, to use the following schedule of penalties for unlicensed practice:

- Unlicensed Shop:
 - First Violation: \$1000 fine.
 - Second Violation: \$2500 fine.
- Unlicensed Employee (First Violation):
 - Shop Owner: \$100 fine for each unlicensed employee, and \$100 fine for aiding and abetting unlicensed practice for each unlicensed employee. Shop Owners

may be fined an additional \$100 for failing to cooperate if an owner does not provide information about an employee when asked.

• Individual: \$500 fine for unlicensed practice.

The MOTION passed unanimously.

Permissible Depth of Skin Services

The Board heard testimony from Attorney Marco Beatrice regarding the permissible depth of microneedling.

After brief discussion, a MOTION was made by Ms. Saluto, seconded by Ms. Tool, to table the issue and instruct the staff to draft a policy with research on microneedling and other techniques that affect skin below the stratum corneum, the outermost layer of skin.

The MOTION passed unanimously.

Public Comments

Mr. Beatrice stated that physicians should not have to obtain salon licenses for med spas.

David Vo of Jupiter Beauty Academy asked the Board to increase penalties for unlicensed practice.

A MOTION was made by Ms. Talbot, seconded by Mr. Gayzagian, to adjourn the meeting.

The MOTION passed unanimously.

The meeting adjourned at 1:41 p.m.
