**GENERAL CONDITIONS OF PROBATION**

1. You shall obey all local, state, and federal laws and all court orders.
2. You shall report to your assigned probation officer at such time and place as directed.
3. You shall notify the probation officer immediately of a change of residence or employment.
4. You shall not leave the Commonwealth without the express permission of the Probation Department, and, if permission is granted, you shall sign a waiver of extradition and rendition before traveling.
5. If you are incarcerated, you shall report to the Probation Department within 48 hours after you are released from incarceration or on the next business day following a weekend or court holiday.
6. You shall immediately inform the Probation Department of any new criminal charge(s).
7. You shall allow the probation officer to visit you at home, school, or place of employment at any time with or without notice.
8. You shall sign all releases necessary for supervision and verification of compliance with these conditions of probation.
9. You shall not unlawfully receive, possess, control, or transport any drugs, weapons, explosives, firearms, or ammunition.
10. You shall pay the probation supervision fee, if required by law, unless waived by court order, or perform community service, if ordered by the court.
11. You shall pay all court ordered assessments and fees.

**SPECIAL CONDITIONS OF PROBATION**

- G **DNA SAMPLE:** You shall submit a DNA sample in accordance with G.L. c. 22E, § 3 and pay the required fee unless waived by the Court.
- G **NO CONTACT:** You shall have no direct or indirect contact with: \_\_\_\_\_
- G **ILLEGAL DRUG/ALCOHOL USE:** You shall not consume  illegal drugs  alcohol and shall submit to random testing as directed by the probation officer.
- G **SUBSTANCE ABUSE:** You shall submit to evaluation and treatment for substance abuse as directed by the probation officer.
- G **MENTAL HEALTH:** You shall submit to evaluation and treatment for mental health issues as directed by the probation officer and shall take medications as prescribed.
- G **SPECIAL PROGRAMS:** You shall complete the following program(s): \_\_\_\_\_
- G **EMPLOYMENT/EDUCATION:** You shall seek and maintain employment, or participate in educational or training programs as directed by the probation officer, and shall provide verification as directed by the probation officer.
- G **SEX OFFENDER REGISTRATION:** You shall register with the Sex Offender Registry Board and local police in accordance with G.L. c. 6, § 178E, shall wear a GPS or comparable device in accordance with G.L. c. 265, § 47, shall abide by the geographic exclusion zones specified on the Order of GPS Supervision Conditions form, and shall pay the required fees unless waived by the Court.
