Board of Elevator Regulations 1000 Washington Street, Boston, MA 02118 1st Floor – Room 1G March 27, 2018

The Board discussed the following:

1. 56 Bank Row – Greenfield, MA [Exhibit 1]

State ID: 114-P-17500

524 CMR

Petitioner: Robert W. Hall Consulting Engineers, Inc.

The petitioner came before the Board requesting a variance for the vent height in the machine room, which was unable to be maintained at 6'. The petitioner stated that the existing building had no existing elevator and the elevator shaft originates in the basement without a stop and connects four floors. At the top of the roof line, the hoistway is vented with a 3 sq. ft. relief tied into both a temperature sensor and smoke detector. The elevator machine room is also located within the basement and is roughly 3 feet from

the hoistway. A 1 sq. ft. duct was provided between the machine room and the hoistway, within a 2-hour enclosure, with a fire damper accessible from within the elevator machine room. The Board had additional concerns, which may require future variance requests. A motion was put forth by Eric Morse to deny the petitioner's request, based on the reasoning that the machine room and hoistway are newly constructed. Also, there appears to be additional solutions, which will allow both the venting and machine room height to be in compliance with the code. The motion was seconded by Cheryl Davis.

3. 135 Spark Street – Brockton, MA [Exhibit 2 and 2A]

State ID: 44-F-269

Relief from Inspector's Report Petitioner: Mark Corvese

The petitioner came before the Board seeking relief from an Inspector's Report citing 524 CMR Section 17.10 (11) – Bi-parting freight doors do not have plug proof on interlocks. The petitioner stated that according to the recent inspection, an OPSI's (Office of Public Safety and Inspection) inspector stated that it is possible for a person outside the elevator to override the interlocks on the bi-parting door locks before the elevator moves off the floor, allowing the bi-parting doors to remain in the open position. The petitioner stated that they have occupied the building for 21 years and there has been no knowledge of an incident related to this issue, and the elevator is primarily used by a single rider or as a dumbwaiter. Also, there is a financial hardship associated with having an elevator retro fitted with custom made parts, in order to be compliant. A motion was put forth by David Morgan to place the petitioner's request on hold for 90 days, until a Supervisor or the Technical Code Coordinator can revisit and confirm if the door lock is in fact, pluggable or not. The motion was seconded by Eric Morse.

Vote: 7-0; Placed on hold for 90 days.

4. 900 Boylston Street – Boston, MA [Exhibit 3 and 4]

Petitioner: Robert Champi

The Chairman notified the Board that the petitioner submitted the variance applications that same day the Inspector showed up at the inspection site. Both units listed above were cited for missing safety switches. The petitioner agreed to install the safety switches and since have done so. The two escalators have since been re-inspected and passed; therefore

a variance is not required and the petitioner's request has been withdrawn.
