On May 23, 2018, Congress gave approval to legislation that would **expand the eligibility for the Department of Veterans Affairs comprehensive caregiver program** to veterans catastrophically injured before September 11, 2001. The bill also includes provisions regarding the VA’s community care programs, the Choice program, and the hiring of healthcare professionals.

MONTHLY SPOTLIGHT

Boston Senior Home Care's Partnership with Local Libraries Brings Savvy Caregiver to Boston Communities



Bringing supportive services to family caregivers where they are in the community is a critical part of Boston Senior Home Care's (BSHC) mission.

Throughout the past year, BSHC has partnered with local public libraries to host the evidence-based Savvy Caregiver program. Thus far, two sessions have been conducted with outstanding retention rates. Overall, 20 out of 23 caregivers completed the 6-week course. Lisandra (Lisa) Parrilla-Clarke, BSHC's Director of Care Management, credited two factors for the program's success. One is the emphasis on sharing personal stories and tailoring delivery to participant needs. The other is related to providing resources, such as technology through the ADSSP Grant, at the sessions themselves. The libraries have also realized how valuable these sessions are to their communities and have proactively contacted BSHC about hosting additional Savvy sessions.

BSHC is constantly innovating to meet the needs of local family caregivers. Related to Savvy, BSHC intends to host a reunion for all caregivers who completed the program. More broadly, they plan to start support groups throughout the Boston area and continue to support the Executive Office of Health and Human Services Caregiver Lunch and Learn.
