Enclosed please find a check made payable to the Commonwealth of Massachusetts in the amount of \$100.00. Also enclosed, please find an original and one (1) copy of the proposed revisions of the Intrastate Telecommunications Services Tariff M.D.T.C. No. 3 of CRC Communications LLC ("CRC"), which carriers and effective date of July 31, 2018. The proposed filing consists of pages 2 and 7. As requested in the Massachusetts DTC's Notice dated June 4, 2018, CRC has also submitted this filing electronically to dte.filing@state.ma.us.

This filing is made pursuant to the Federal Communications Commission's *USF/ICC Transformation Order* ("Order"), which established that individual intrastate rates for dedicated access local transport, terminating switched access, and associated services must be equal to or lower than their corresponding interstate rates. Accordingly, CRC has made the following revisions:

- Reduced its Switched End Office and Transport – Terminating from \$0.000700 to \$0.000000

Lastly, CRC does not own a tandem switch that services intrastate access traffic in Massachusetts.


