Each year the Massachusetts Department of Conservation and Recreation Urban & Community Forestry Program, the Massachusetts Tree Wardens' and Foresters' Association, and the USDA Forest Service offer a two-day **Tree Steward Training** program for local Tree Committee members, Tree Wardens, tree activists, municipal officials, and other individuals interested in learning about improving their community through urban and community forestry. This year's training will be held October 12-13 at Harvard Forest in Petersham. Trained Tree Stewards then return to their communities where they put their learning into practice working to improve their city or town's community trees and forests.

The cost of the Tree Steward Training is \$55 (with an additional \$75 for those who require overnight accommodations), and we encourage interested individuals to approach local businesses to act as a local sponsor of their registration fee. We are writing to ask if you would be willing to become a sponsor.

Community trees add so much to the vitality of our cities and towns. They bring beauty, shade, and environmental benefits, and recent research has even demonstrated that community trees contribute significantly to the economic vitality of an area.
