Review Minutes:

Minutes of March 21, 2018 meeting reviewed.

Board members discussed changes to clarify the discussion on page 2 regarding past licensure requirements. Dr. Sabree moved to accept the minutes as amended. Dr. Sarkis seconded the motion. The motion passed unanimously.

Report from Executive Director:

• Applications appear to be being processed properly and transmitted by PCS. There have been two new licenses issued since the last meeting.

Report from Board Counsel:

- Reciprocity/Endorsement evaluations and process no reciprocal applications.
- Legislative update no news

Discussion:

- Medical Malpractice Tribunals The Massachusetts Superior Court has published a new Rule 73 that requires licensing boards, such as the board of optometry, to provide upon request lists of licensees who are willing to participate in medical malpractice tribunals and who do not practice in the same county as the defendant. Attorney Andrea Davulis wrote to request that the Board provide her with a contact person from whom she can request that list. Since this rule would affect several boards at the Division of Professional Licensure, Board Counsel will work with Chief Legal Counsel and agency administration to formulate a response.
- Association of Regulatory Boards of Optometry ("ARBO") Board report ARBO has
 requested that the board update and provide annual information for its report. The Board
 discussed what issues were currently important to the board. Among them were
 glaucoma legislation, patient access and mobility, corporate practices that tend to
 undermine the doctor patient relationship and on-line eye exams which may impact
 public safety. Board staff will update report.
- ARBO call for nominations ARBO sent a request for nominations to its board of directors and to its council on optometric education. The Board read and filed the request.
- Accreditation Council on Optometric Education ("ACOE") Standards and call for comments on proposed changes – ACOE sent a copy of their standards with proposed changes. The Board reviewed and proposed that the ACOE add state regulations to the accepted standards identified in item 8.3.
- Question from Douglas Haigh, OD, regarding the use of Pharmaceutical agents –
 Optometrist Douglas Haigh contacted the Board to ask whether, under Massachusetts
 regulations, Optometrists may use oral or schedule 5 pharmaceutical agents. The Board
 directed board counsel to advise Dr. Haigh that per the licensing statute neither oral nor
 schedule 5 pharmaceutical agents may be used by Massachusetts Optometrists.
