### **Board Business:**

1. At 9:16 a.m., the meeting was called to order by Dr. Carey.
2. Dr. Carey reviewed evacuation instructions.
3. On a motion by Dr. Howe, seconded by Dr. Hudgins, the board meeting minutes were unanimously approved from the February 9<sup>th</sup> meeting.
4. Applicant Lugo-Estrada: On a motion by Dr. Scherer, seconded by Dr. Howe, the board agreed to allow the applicant time and one half accommodation for the EPPP. All were in favor.
5. Applicant Saltman: On a motion by Dr. Scherer, seconded by Ms. Allen, the board agreed accept the waiver of the 5 year rule to allow applicant to sit for EPPP. All were in favor.
6. Applicant Lawrence: On a motion by Dr. Scherer, seconded by Ms. Allen, the board voted to allow the applicant to move forward with their application reinstatement with no HSP. All were in favor.
7. Applicant Greenberg: On a motion by Dr. Glover, seconded by Ms. Allen, the board voted to require the applicant take the 6 courses from an accredited doctoral program to meet the academic criteria for their application and to suggest considering enrolling in a respecialization program to address both coursework and supervised practice deficiencies. All were in favor.
8. Applicant Frechette: On a motion by Dr. Scherer, seconded by Dr. Howe, the board voted to allow the applicant to move forward with their application. All were in favor.
9. Applicant Fuzzetti: On a motion by Dr. Howe, seconded by Dr. Scherer, the board voted to invite the applicant to meet with the board and to provide a copy of their CV in order to discuss the training experiences indicated in their application. All were in favor.

10. At 9:50 am, Ms. Allen, moved, and was seconded by Dr. Scherer, and all were in favor to enter into closed session for the purpose of conducting investigative conferences, pursuant to G. L. c. 112, § 65C, for: PY 2017-000912-IT-ENF (lawyers present for both licensees).

11. At 12:12 pm, on a motion by Dr. Scherer, seconded by Dr. Anderson the board moved from closed session to open session.

12. There was no board counsel report.

13. Discussed upcoming September hearing attendance needs.

14. Dr. Reinke provided a supervisor for board consideration (Dr. Pollack). On a motion by Dr. Glover, seconded by Dr. Howe, the board voted to accept Dr. Pollack as supervisor.

15. The board, by unanimous consent, decided to invite the proposed supervisor for Dr. Bean (Dr. Posner) to meet with the board.

16. EPPP correspondence: Awaiting response from New York Board of Registration to oppose the changes to EPPP. Board will table the discussion until after hearing back from the New York Board of Registration.

17. On a motion by Dr. Anderson, seconded by Dr. Howe, the board unanimously approved administratively reviewed applications.

18. At 12:31 pm, on a motion by Dr. Allen, seconded by Dr. Anderson, the board voted to exit open session and enter into executive session to discuss medical record information and to comply with the public record law, pursuant to G. L. c. 66, § 10; G. L. c. 4, §7, ¶ 26(c)). Following a roll call vote, all in favor, the motion passed.

19. At 12:34 pm, on a motion by Dr. Scherer, seconded by Dr. Howe, the board voted to exit executive session, enter open session and to recess for lunch. Following a roll call vote, all in favor, the motion passed.

20. At 1:15, Dr. Scherer moved to exit open session and to enter closed session for the purpose of conducting investigative conferences, pursuant to G. L. c. 112, § 65C, for: 2017-001035-IT-ENF, 2017-000263-IT-ENF, 2017-000137-IT-ENF, 2017-001243-IT-ENF. Dr. Marshall seconded and all were in favor.

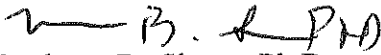

24. PY 2017-000137-IT-ENF: On a motion by Dr. Hudgins and seconded by Dr. Howe, the board voted to dismiss the complaint. All were in favor. (Dr. Carey took no part in the discussion of or deliberation upon this matter.)
25. PY 2017-001243-IT-ENF: On a motion by Dr. Scherer and seconded by Dr. Howe, the board unanimously voted to dismiss the complaint with an advisory letter.
26. PY 08-004: On a motion by Dr. Scherer and seconded by Dr. Howe, the board unanimously voted to deny the motion for reconsideration.
27. PY 2017-000912-IT-ENF: On a motion by Dr. Scherer and seconded by Dr. Howe, the board unanimously voted to forward the matter to prosecutions and to open an additional complaint and to forward that matter to prosecutions.
28. At 2:50 p.m., on a motion by Dr. Scherer, seconded by Dr. Marshall, the Board unanimously voted to adjourn.
