### **Board Business:**

1. At 9:06 a.m., the meeting was called to order by Dr. Carey.
2. Dr. Carey reviewed evacuation instructions.
3. On a motion by Dr. Bistis, seconded by Dr. Howe, subject to corrections of Dr. Bistis being present in the meeting and adding Dr. Marshall's missing credential, the board meeting minutes were unanimously approved from the April 13<sup>th</sup> meeting. (Dr. Bistis recues)
4. Applicant Phillips: On a motion by Dr. Bistis, and seconded by Dr. Anderson, the board agreed to allow the applicant to move forward with their application. All were in favor.
5. Applicant Mundt: On a motion by Dr. Howe, seconded by Dr. Scherer, the board agreed to accept request more information be provided by the applicant regarding their training program details and documentation of time spent while not on internship site. Also requiring a current supervisor of the applicant's program to complete the supervision form of the application. All were in favor.
