1. At 9:12 a.m., the meeting was called to order by Dr. Carey.
2. Dr. Carey reviewed evacuation instructions.
3. Introduction of new Executive Director, Brian Bialas.
4. On a motion by Dr. Jones, seconded by Dr. Hudgins, the board meeting minutes of both the public meeting and executive session from the January meeting were approved. The board noted that the executive session minutes should be held confidential because the purpose of the executive session still warrants confidentiality. All were in favor.
5. No Board Counsel Update
6. Reviewed email correspondence from Dr. Randi Dorn. Executive Director will draft a response addressing question to clarify how and whether treatment and assessment will be counted towards clinical experience.
7. Applicant Review: Applicant Shanta Griffin. The board agreed to invite the licensee to meet with the board to discuss her application.
