Net Metering Petition Checklist Form

I. INSTRUCTIONS

Per D.P.U. 17-22-A, all stakeholders requesting a net metering exception from the Department of Public Utilities ("Department") shall submit the checklist below with their petition:

- If a petitioner is seeking an exception to the **Single Parcel Rule**, the petitioner shall fill out sections II, III, IV, and V.
- If a petitioner is seeking an exception to the **Subdivision Rule**, the petitioner shall fill out sections II, III, IV, and VI.
- If a petitioner is seeking an exception from the **regulations for reasons other than the Single Parcel Rule or Subdivision Rule**, the petitioner shall fill out sections II, III, and IV.

In all sections, petitioners must identify in column 3 the page number or attachment reference in the petition where the answer to each question may be found. If a question is not applicable to the petitioner's situation, the applicant should write "N/A" in the cell. Cells should not be left blank. Incomplete responses may result in the issuance of a Notice of Deficient Petition by the Department to the petitioner. See e.g., The Pomponoho Pines Community, Notice of Deficient Petition for an Exception from the Net Metering Regulations D.P.U. 19-33 (2019).

Answers to the petition checklist questions should focus on the net metering program. If you are seeking an exception to the Solar Renewable Energy Certificate ("SREC") or Solar Massachusetts Renewable Target ("SMART") Program do NOT fill out this form, instead, contact the Department of Energy Resources.

11	Provide each net metering facility nameplate capacity in kilowatts alternating current ("AC").

14	Indicate the owner of each net metering facility.	
15	Indicate the offtaker(s) of each net metering facility. If there are multiple offtakers, indicate what percent of the credits generated will be allocated to each offtaker.	
16	Provide the expected annual output of each net metering facility in kilowatt-hours ("kWh").	
17	Provide the yearly energy consumption for each of the previous three full calendar years (e.g. 2016, 2017, and 2018), in kWh, for the meter behind which each net metering facility will tie.

The drawing should include at a minimum: the (1) solar arrays, (2) inverters, (3) meters, and (4) interconnection point(s).
