VARIANCE REQUESTS

PV-97-Mighty Squirrel Beer Company-411 Waverly Oaks Road - Waltham

Patrick Andrews of The Mighty Squirrel Beer Company is seeking relief from 248 CMR 10.10 (18) Table 1 requirement of a shower for employee (Industrial Factory / Warehouse and Similar Usage) 1 per 15. Applicant claims a lack of floor space on the upper floor level and extensive removal of the floor slab on the lower level as a hardship. The Waltham Board of Health has been properly notified.

PV-98 – Starbucks, Market Place Logan LLC – 1 Harborside Drive Terminal B - Boston

William Brady of Vanderweil Engineers is seeking a variance for Starbucks at Logan Airport. The variance request is the elimination of the required grease interceptor that is triggered by the 12" bowl depth of the custom made Elkay work sink. This sink is at the coffee brewer station, and is not for use with grease-laden waste. This is state property, therefore no Board of Health notification is required.

PV-99 – Temazcal Restaurant, Market Place Logan LLC – 1 Harborside Drive Terminal B - Boston

William Brady of Vanderweil Engineers is seeking a variance for Temazcal Restaurant at Logan Airport. The variance request is for a non-product accepted custom made trough that will be located below a tilting skillet. This is state property, therefore no Board of Health notification is required.

Garett Pennucci is seeking relief from 248 CMR 10.06 (2) (o) 3. Limited use of PVC in Commercial Buildings. The building is constructed on a pier which extends over the open ocean. The under floor sanitary piping will be exposed to the elements (salt air and salt water splash). They are requesting the use of PVC Schedule 80 pipe. The Edgartown Board of Health has been properly notified.

Kevin Provencher of PDA Incorporated is seeking a variance from 248 CMR 10.10 (18) (i) 2. Travel distance to employee toilet rooms. The proposed addition will act as an extension of their existing warehouse storage facility. The Taunton Board of Health has been properly notified.

The Quincy Adams Station Parking Garage will be staffed with 2-3 employees maximum during all hours of operation. The request is for a single user ADA compliant gender neutral toilet room.

The second variance is to allow the use of a bottle water station in lieu of a plumbed drinking fountain. Since this is State owned property no Board of Health notification is required for staff only.

The Newton Health Department has been properly notified.

They are asking that each small space not provide individual toilet and sink but rather to rely on core facilities located between 50 and 150 feet from the storefronts. APPEAL OF AN INSPECTOR'S DECISION

Withdrawn AID - 96 - Mike Espinola - 5 Water Street - Danvers

Petitioner Mike Espinola is aggrieved by the Danvers Gas Inspector's decision. The applicant claims the inspector failed a job due to the use of PVC schedule 40 plastic piping being used to vent the products of combustion for gas furnaces and hot water heaters. The aggrieved states the reason for the appeal as "not a code violation". The date of the Inspector's decision is listed as October 23rd, 2018. The Board Office received the appeal application on October 29th, 2018. It appears the applicant is within the 10 days per MGL c 142, s 13. Norman St. Halaire is named on the appeal.

The conditions for approval are: 1) A variance application submittal. 2) Only 1 shower per variance. 3) Legitimate health concern with medical note. 4) A 6" threshold from shower surface to top of barrier lip. 5) Only one 2.5 gallon shower head. A letter to grant variance with conditions has been sent to the applicant. The Franklin Board of Health has been properly notified.

The conditions for approval are: 1) A variance application submittal. 2) Only 1 shower per variance. 3) Legitimate health concern with medical note. 4) A 6" threshold from shower surface to top of barrier lip. 5) Only one 2.5 gallon shower head. RE: Greenhouse - 220 Sandwich Road - Bourne

Project at school (greenhouse): Replace 2 existing gas fired Reznor heaters with 2 gas fired Modine Hot Dog Heaters. Maximum of 4 students working on project. (Juniors and Seniors).
