The Board discussed the following:

 267 Lakeview Avenue – Cambridge, MA [Exhibit 1] Product Variance 524 CMR

Petitioner: Paul Farnsworth

The petitioner was previously in front of the Board on May 7, 2019 seeking a product variance for a Pneumatic Vacuum Elevator Model PVE 30, manufactured by Pneumatic Vacuum Elevator, LLC. The petitioner made an opening remark commending the Board

for its work. The petitioner stated that the PVE 30 is a smaller version of the previously approve model PVE 37. The PVE 30 is 7 inches smaller in diameter than the PVE 37, with a rise 15 meters (approximately 50 feet), and will only be installed in single family owner occupied dwellings. The petitioner also stated that he would like to investigate going higher at some point but would accept 32'travel limitation at this time. The petitioner provided a letter stating the glass enclosure would be replaced every 10 years due to scratching and an inspection checklist will be supplied. The testing schedule will commence every two years. Board member John O'Donoghue requested that the petitioner forward pictures of the fuses for fire service. A motion was placed by Cheryl Davis to place the petitioner's request under advisement. The motion was seconded by Eric Morse.

2. 57 Union Street – Newton Centre, MA [Exhibit 2]

State ID(s): TBD – New Installation

A18.1-2016 Section 3.1.2.2 Petitioner: Paul Farnsworth

The petitioner was previously in front of the Board on May 7, 2019 seeking a variance from A18.1-2016 Section 3.1.2.2, which requires a minimum of 81-1/4" of overhead clearance. The petitioner stated that the current overhead clearance is 65" and the manufacturer requirement for the proposed installation of a Savaria Delta Inclined Platform Lift is 66 -1/16". The petitioner stated that there is a 1" clearance to the ceiling with the cut-out. The building owner would be willing to modify the structure in the floor above to include a greater clearance. Board member Eric Morse stated if the petitioner meets the 60" then that unit will be in compliance with the code. The petitioner agreed to provide "Low Overhead" signage. A motion was placed by David Morgan to place the petitioner's request on hold for 30 days. If the Board does not receive a response within 30 days, the petitioner's request will be considered withdrawn. The motion was seconded by John O'Donoghue.

5. Variance requests for 9 Dale Avenue, Gloucester and 1 Charles Street, Boston were

withdrawn per the petitioners.

6. A motion to go into quasi-judicial session was placed by David Morgan to review the

product variance request for 267 Lakeview Avenue, Cambridge. The motion was

seconded by Cheryl Davis. The Board unanimously agreed to have legal counsel draft a

decision with a subsequent site visit.

7. Board member John O'Donoghue wanted a follow-up with Chief Sampson in regards to

the proposed changes to the Fire Fighter Extraction form.
