#### On the Road ~ Testing Text-to-911

As the public awareness of Text-to-911 increases across the United States, the use of it may also increase in our state. With the summer months upon us, Massachusetts sees an influx of out-of-state travelers and an increase in the need for emergency services. It is important that your PSAP knows exactly what to do.

Over the coming months, members of the Programs Division's Training Team will be available to perform quality assurance testing for Text-to-911 within your PSAPs and provide on-site training for personnel. This will provide your PSAP staff with the opportunity to have hands-on training with the Text-to-911 feature and ask questions about any aspect of the Next Generation 9-1-1 applications.

We also encourage PSAPs to continue to regularly test Text-to-911 with each shift to ensure they have a complete understanding of the technology behind Text-to-911 and the protocol. Please remember that all test text messages should have the following wording as the initial message **"This is a TEST text message for (PSAP name)"** or similar.


# Updates from our Systems Division

#### **Updates to ResponseAssist**

Initially intended to report map feature display anomalies, the discrepancy report feature is now expanded to effectively support reporting map feature and 9-1-1 call incident discrepancies. Now, when processing a discrepancy in ResponseAssist, separate user interface options enable you to open a report dialogue box tailored to the nature of the discrepancy. The main goal of the feature enhancement is to streamline and standardize the discrepancy reporting process.

#### **Discrepancy Report Tool**

Based on the discrepancy type selected from the **Discrepancy Report** tool menu (pictured to the right), a completed report is delivered to targeted recipients assigned to reconcile the reported issue.



#### **Map Discrepancy Report**


The Map Discrepancy Report dialog box interface (pictured below) will remain very similar to previous versions with only small changes.

The first change is the "Discrepancy type" menu options (highlighted in orange) are now limited to only two choices: "New GIS information" and "Associated with a PIDF-LO discrepancy". The "New GIS information" selection should be used when there is information not displayed on the map. The "Associated with a PIDF-LO discrepancy" option will be the same as previous, allowing specific notes to be entered

relating to a mapping error on the visible map in the discrepancy dialog box.

The second change is that the read-only configuration displays on the input form have been removed.

Please note: The format for submitting the report by e-mail has not changed.

#### **NEW! Incident Discrepancy Report**

When a 9-1-1 civic event is received (not a dynamic event, such as a wireless call) with a location discrepancy conveyed from the caller, users can now enter updates for the call record in a prepopulated form when selecting **Incident Discrepancy Report**.

The form's table (as pictured below) lists the call location attributes and automatically populates existing attribute values based on the active Incident Tile in the application's Incidents window. In order to have the correct values populate, the user must select the appropriate Incident Tile.

The telecommunicator will be able to enter new or reported information provided by the caller, that deviates from the existing call data visible, into the respective attribute field(s) under the **New Value column** (highlighted yellow).

If an existing call attribute is not relevant for the location, it can be flagged for removal by checking the box in the **Omit column** (highlighted green).
