

Initiative Petition for a Law Relative to the requirement for all gun owners to secure all weapons stored, maintained and kept in their place of residence, business and vehicles within a certified gunsafe.

Note: "weapon(s)" within the text of this Initiative Petition refers to any and all rifles and handguns regardless of munition type or caliber.

Be it enacted by the People, and by their authority:

That within Massachusetts, all gun owners, both residents and visitors, will be held equally responsible for any and all actions and crimes committed by any person(s) using unsecured weapons obtained from any residence, business or vehicle regardless of owner consent or nonconsent.

From the date enacted, this law will provide owners of rifles and handguns with a 6 month "grace period" in obtaining a certified gun safe and mechanism to secure weapons in transit within a vehicle. Additionally, any expense incurred to meet the requirements of this law will be tax deductible from Massachusetts State Income Tax by the purchaser of equipment and/or services required to fulfill the requirements of this law.

At the end of the "grace period", all weapons sales will require proof of ownership of a certified gun safe that the weapon(s) will be housed or transported in prior to delivery of any weapon(s) purchased.
