BOARD OF STATE EXAMINERS OF ELECTRICIANS OPEN SESSION MINUTES

P. Malagrifa made a motion, J. Colleary seconded, and the members present unanimously voted to approve the minutes.

2. Reviewed/Discussed other reports:

a) **Executive Director Report**– The Executive Director reviewed the 2023 Board meeting dates and asked whether the Board would consider suspending the November meeting as he would be on parental leave.

J. Bagni made a motion, P. Malagrifa seconded, and the members present unanimously voted to cancel the November regularly scheduled meeting.

K. Gleason also demonstrated a revised website design, he asked members to communicate any issues they've experienced or heard of to him. He will be continuing to work with the developers and will meet with them in 90 days to assess how the pages are working and will be able to make additional adjustments as necessary.

- b) Office of Investigations The Executive Director mentioned that the investigator Christopher Lee is currently on leave, thus a slight delay in cases may occur. He also noted that J. Bagni has been working with Mr. Lee to improve investigative summary reports.
- c) Legal Counsel Counsel stated that he is finalizing additional paperwork for administrative approval of the regulation amendments but noted the review process can take several months. He added as a reminder that remote meeting allowances are effective until revision in Spring 2023 as the remote allowance expires in March and that the Board may also hold live meetings.
- d) **Board of Fire Prevention Regulations** P. Vigneau reported the fire code is being updated based on the 2021 version of NFPA 1 with amendments, the code is expected to go to public hearing in October. The BFPR Advisory committee is scheduled to meet October 3 to finalize the next edition of the electrical code based upon 2023 edition of NFPA 70 with amendments, after which it will go before the BFPR on October 6 to begin the promulgation process, he indicates it should be on track for a January 1 release. The permit application has been reviewed and changes proposed but the timeline for posting it is yet to be determined.

- b) Education Subcommittee D. Edmonds reported on the meeting held September 15, 2022, where the subcommittee discussed the logistics for the 2023 Providership renewal period beginning October 1 thru December 1. They would like to establish a central electronic hub where staff and the subcommittee is able to centralize application reviews. The intent is to share the work amongst members to facilitate thorough and complete reviews and that, when all members agree, a provider can be approved by unanimous consent rather than individual votes.

 of existing requirements which he felt met the Board's desire to address possible
 confusion regarding licensing requirements. J. Bagni suggested an edit to the title
 emphasizing it pertains to lighting and wiring.

P. Vigneau made a motion, P. Malagrifa seconded, and it was so unanimously voted by the members present to approve the advisory as amended.

The parties appeared, however the appellant requested postponement due to a claim of insufficient notice and disagreement as to exhibits. The chair requested counsel review.

- With regards to notice, counsel opined that the parties may not have received sufficient notice of the hearing so agreed the Board should reschedule the hearing.
- With regards to exhibits, counsel reiterated the purpose of joint exhibits that a joint submittal of exhibits is instructed to eliminate the possibility of redundancies in documentation, however the parties may submit independent documents that are not agreed upon. The Board will resolve any arguments over admitting exhibits.
