- 1) Consideration of the October 24, 2022, meeting minutes.
- J. Colleary made a motion, P. Malagrifa seconded, and the members present unanimously voted to approve the minutes as presented.

2) Reviewed/Discussed other reports:

- a) Executive Director Report— Executive Director Gleason stated that after a thorough selection process PSI was awarded the bid on the examination application processing contract. He added that he will be meeting with PSI in the new year to review common issues and plans to convene the exam questions review committee with the NEC 2023. The 2023 CEP and IEP lists will be updated in January as the subcommittee reviews and approves providers. Also, a new investigator has been hired to the "trades" team.
- b) Office of Investigations No matters reported
- c) Legal Counsel Counsel Kilb mentioned that Counsel Cargill will keep the Board apprised of the regulations promulgation as it progresses. He expressed his pleasure of working with the Board and its current members over the years. The members thanked him for all his work.
- d) **Board of Fire Prevention Regulations** P. Vigneau reported that the new edition of the fire code became effective December 18. Training for fire officials will be available in January. Regarding the NEC 2023, public comments from the public hearing held on December 14 went back to the advisory committee on December 16 where a working group will be considering article 210.8 on GFCI receptacles and the supply issue between appliance manufacturers and GFCI manufacturers. The BFPR would meet today to consider all input and determine the path forward.

5) Discussed subcommittee meetings and reports:

- a) Regulation\CMR Subcommittee No meeting held
- b) Education Subcommittee D. Edmonds reported on the subcommittee meeting held December 14 having reviewed 44 applications of Providers, 33 were accepted. Complete approved Providers will receive email confirmation by Board staff. The next meeting is scheduled for December 28 @ 10 A.M. It was iterated that prior approved Providers who also conduct virtual classes must so indicate interest via an addendum to the application however new applicants for virtual classes must present before the subcommittee. The Executive Director agreed to put together a notice to Providers to notify them of their lapsed approval status in January.
- c) Interpretation Subcommittee No meeting held
- d) **Planning and Research Subcommittee** J. Bagni indicated a meeting will be scheduled in January.
 - i) Discussion of the New Hampshire reciprocal agreement
 - J. Bagni stated that the subcommittee having reviewed and discussed the matter have concluded that changes to New Hampshire's license to apprentice and

- education practices are incongruent with Massachusetts' requiring revision of the reciprocity agreement.
- B. Driscoll voiced concern with New Hampshire having accepted online education programs whereas Massachusetts has not.
- J. Colleary stated his concern that individuals who fail the MA examination entering through reciprocity having found the New Hampshire test to be easier.
- E. Dorian agreed it concerning if exam candidates are finding an easier path to MA licensure with the New Hampshire exam; but she would favor the Board begin the process to accept online education rather than eliminate the agreement.
- Counsel Kilb added that a reciprocity agreement means that the Board has evaluated and determined that the state holds substantially equivalent license criteria so their licensees may be allowed licensure without examination in Massachusetts. He pointed out that MA examination eligibility criteria on out of state licensees does not require evaluation of work ratios on work experience eligibility. He suggested that the Board might consider inviting New Hampshire to discuss possibility of accommodating the Board's concerns and reducing reciprocity eligibility accordingly in lieu of eliminating the agreement altogether.
- P. Malagrifa made a motion, J. Bagni seconded, to terminate the current agreement with New Hampshire withholding acceptance of applications for reciprocity beginning January 1 and pursue a revised agreement that is in alignment with MA license and education requirements.
 - After discussion, the motion was withdrawn.
- P. Malagrifa made a motion, B. Driscoll seconded, to place a hold on applications for reciprocity effective January 1, 2023, pending discussion with New Hampshire Board to create a new agreement that is more consistent with MA requirements for education and licensure.
 - After discussion, the motion was revised.
- P. Malagrifa made a motion, B. Driscoll seconded, to place a hold on applications for reciprocity effective January 1, 2023, pending a discussion with New Hampshire to create a new agreement that is more consistent with MA requirements for education and licensure and New Hampshire's acceptance of the hold on applications pending the discussion. The agreement would be deemed terminated failing New Hampshire's willingness to engage in the discussion or acceptance of the hold on applications.
 - After discussion, the motion passed by a majority of the members present.
