Approximately 60 letters were sent out to Instructors at the end of October. Some requesting hearings, some requesting designation removal, some pursuing broker licensure.

For those that will need to come before the board, they can start to be scheduled for the December board meeting.

Affiliations of all salespersons and some broker: changes to way database establishes affiliation; will run with the brokerage not the broker in charge. The system was temporarily disabled, which resulted in some negative feedback, but the update has been rolled back, to allow advanced outreach.

Application Review

Daniel Corbett— 2022-001536-Rein Salesperson expired in 2016 There was a complaint August 4, 2020. A final decision imposed a revocation based upon finding on liability for practice with an expired license and receiving funds beyond scope of salesperson's license and default at the scheduled sanctions hearing. Mr. Corbett would like the revocation removed and the license reinstated.

The board asked him why he should be reinstated. He stated he sent a letter to the board from his doctor stating he could not attend a previously rescheduled sanctions hearing. Mr. Corbett claims he never did anything wrong. He was not aware his license was expired. He states he did not act as a broker in this situation.

Voted: To deny request to remove revocation and thus to deny candidate reinstatement.
