  - a) **Regulation**\**CMR Subcommittee** No meeting held
  - b) Education Subcommittee No meeting held

  - d) **Planning and Research Subcommittee** the subcommittee is scheduled to meet February 28, 2023.
  - 5) Discussed Reciprocity Agreement with New Hampshire.
    - The chair stated the matter was returned to the education subcommittee.
- 6) Discussed use of electronic communication (email) to meet the requirements of MGL Part I, Title XX, Chapter 143, § 3L
  - J. Colleary stated that requests for inspections by email are becoming more prevalent therefore he asked for the Board to opine as to whether email is an acceptable means of notification.
  - Counsel Kilb mentioned MGL c110G Uniform Electronic transactions Section 7. "(a) A record or signature may not be denied legal effect or enforceability solely because it is in electronic form..." and added that the BFPR has the authority to regulate the permit process by way of regulations and the permit form whereas the Board would only be involved when issuing rulings on appeals.
  - D. Clemons asked that the Board compile the issues in writing that he can then convey to his board.
  - The chair opened the meeting to public comment:
    - Peter Diamond mentioned that rule 8 of the MEC was already amended to address and reference MGLc110G and iterated the caveat in section 5 "b) This chapter applies only to transactions between parties each of which has agreed to conduct transactions by electronic means..."
  - The Board moved the matter to the Planning and Research committee to formulate the letter.

# 7) **Discussed** potential advisory to Inspectors on issuing permits in absence of a business license.

- J. Colleary mentioned that he believes there is confusion among Inspectors as to when it is appropriate to issue permits in absence of a business license.
- Counsel Kilb stated that regarding the issuance of permits to businesses that hold an A1/C1 licenses, the Licensee of record and business name would be indicated on the permit form as published by the BFPR. Journeyman or Technician licensees, however, would not be allowed to obtain an A1/C1 license or conduct business like a Master/Contractor because they can only practice in their own name and technicians are not eligible for obtaining permits on their own. He further noted that institutions or other entities not engaged in the electrical business would not be required to obtain the business licenses.
- The Executive Director confirmed that the new permit form has been published by the BFPR and link referenced via the Board's website.
- The Chair stated that the Board would not being taking action on this matter at this time.

#### 8) Discussed approval for Licensee, Roger Gaydou to be Licensee of record for a third electrical business

- The Executive Director stated he invited Mr. Gaydou to address the Board and asked for the Board's guidance as to assigning a third business to a licensee of record.
- Mr. Gaydou stated that the business had not yet applied for the license but was seeking guidance.
- J. Bagni reiterated that the Board directed in the past that three or more businesses must appear before the Board once the application is submitted.
- Mr. Gaydou was instructed to make application first, then the matter will be addressed.
- 9) Discussed other matters not reasonably anticipated 48 hours in advance of the meeting. No Matters presented.
