- 5) **Discussed** subcommittee meetings and reports:
- a) **Regulation\CMR Subcommittee** – No meeting held
  - b) **Education Subcommittee** – D. Edmonds state the subcommittee is next scheduled to meet May 10, 2023.
  - c) **Interpretation Subcommittee** – No meeting held
  - d) **Planning and Research Subcommittee** – J. Bagni reported state the subcommittee is next scheduled to meet May 10, 2023.
- 6) **Discussed** Current landscape of the apprenticeship programs, specifically with regard to both reciprocity & registration within the NE states.
- Mario Paiva, MA Division of Apprentice Standards addressed the Board stating that there appears to be a trend of businesses that are operating within multiple adjoining states possibly gaining incorrect credit for licensure.
  - By request, legal counsel reviewed the Board’ role with apprentices and noted the Board does not license apprentices but regulates statutory ratios and credit for upgrading.
  - Board members inquired as to whether they could license apprentices but legal counsel noted that absent a statutory change, no such requirements could be imposed.
  - No formal action taken.
- 7) **Discussed other** matters not reasonably anticipated 48 hours in advance of the meeting.
- Adam Norcott asked regarding the CE requirements for inspectors. The Board noted this out lined in Provider guidelines.
  - Bev Kennedy inquired as to when the exam would feature the 2023 NEC. The Executive Director stated he expects that the delayed adoption of the code would likely result in a corresponding delay in updating the exam but arrangements to update the examination are ongoing.
