## WMA Permits

- Most WMA Permits require reductions in nonessential water uses when one or more of the following are triggered from 5/1 - 9/30:
  - Specific streamflow triggers generally include
    - June ABF is the May June trigger
    - August ABF is the July September trigger
  - Groundwater elevations on Cape, Islands and parts of Southeastern MA
    - Triggers are the period of record monthly 25<sup>th</sup> percentile depth to water level values, as determined and published by the USGS; and
  - Drought Declaration or 7-Day Low Flow

## WMA Registrations

- WMA PWS and Golf Registrations now require reductions in nonessential water uses when the Secretary declares drought for the region, county, or watershed.
  - Level 1 (Mild Drought): nonessential outdoor water uses restricted to 1 day per week, from 5 pm to 9 am, exceptions for ornamentals and gardens with drip irrigation, hand-held house or watering cans may be permitted.
  - Level 2 (Significant Drought): nonessential outdoor water uses are banned, exceptions for ornamentals and gardens with drip irrigation, hand-hold hose or watering cans may be permitted.
  - Level 3 (Critical Drought) or Level 4 (Drought Emergency): All nonessential outdoor water uses are banned.


## WMA Registrations

- Implementation of restrictions on nonessential outdoor water use shall begin as soon as possible, but no later than 24 months after issuance of the Registration Statement.
- PWSs that are supplied entirely by reservoirs with multi-year storage have the option of developing a system-specific Drought Management Plan.
- Lawsuit filed February 17, 2023 by 23 entities claiming an infringement on their Registered withdrawals.

#### **Restriction Numbers**

- 05/10:
  - 0 Voluntary restrictions
  - 37 Mandatory restrictions of 3 days or more
  - 25 Mandatory restrictions of 2 days or less
- 05/30:
  - 1 Voluntary restrictions
  - 45 Mandatory restrictions of 3 days or more
  - 30 Mandatory restrictions of 2 days or less
